## **GENERAL DISCUSSION**

3. <u>AI-43347</u> Utilization of existing City House grant funds for the purchase of a new shelter, Administrative Services.

Sheri Messer, City House, came forward to request using previously awarded funds to purchase a new shelter. In 2013 City House was granted \$220,000 to do a two house program. One house was purchased and set up for a shelter for girls; however, there were issues with the HOA (Homeowners Association) resulting in the sale of the house in March 2017. Because of the issues with the HOA City House did not purchase a house for a boys shelter and returned \$110,000 of the funds to the Housing Finance Corporation. Ms. Messer said after much searching for an affordable house, City House is now ready to purchase another property for girls. The potential property is a duplex and if City House purchases it there will be tenants in one side until the end of the year.

The other side will be available in 45-60 days. Rental income will be made from the leases and those funds will go towards the rehab of the property. Before moving forward City House wanted to make sure the Board was fine with a delay of filling the property. A motion was made to approve City House changing houses for a shelter for girls. (Time: 3:05 p.m.)
