RE: Frontier Parkway Engineering Services Agreement Collin County Contract No. 2016-229 Collin County Purchase Order No. 199212 Amendment No. 3

Dear Mr. Daugherty:

As you requested, we are pleased to submit Amendment No. 3 to our Engineering Services Agreement with Collin County dated Sept. 27, 2016 (Collin County Purchase Order No. 199212) for the design of Frontier Parkway, from the Dallas North Tollway (DNT) to S.H. 289 (Collin County Contract No. 2016-229).

This Amendment No. 3 makes the following changes to the original agreement:

- 1. The Geotechnical Explorations and Engineering phase services are now know to be more effort than originally envisioned. This Amendment No. 3 revises the Geotechnical Engineering budget to reflect the additional scope and effort.
- 2. The environmental phase services are now expected to be less effort and possibly more streamlined than originally envisioned. This is due in part to the assistance provided by the North Central Texas Council of Governments in the through the Section 214 Federal Water Resources Development Act of 2000 (WRDA).

Refer to Exhibit C – Engineering Services Fee Schedule:

The fee schedule shown in Exhibit C is hereby modified to increase the fee for Part B.3 – Geotechnical Investigations and Report by \$36,499, or a maximum not to exceed amount of \$77,199; and to reduce the fee for Part B.5 – NCTCOG Environmental Form by \$5,000, or a maximum not to exceed amount of \$22,000; and to reduce the fee for Part B.6 – 404 Permit Application (Nationwide Permit 14) by \$31,499, or a maximum not to exceed amount of \$47,751. The net effect of these changes does not change the overall contract amount approved.
