(3) 1115 Waiver Update Re:

Background:

Texas Health and Human Services Commission (HHSC) and the Centers for Medicare and Medicaid Services (CMS) have reached an agreement to continue the 1115 Waiver in the amount of \$25 billion over the next five years. The current extension for the waiver was set to expire on December 31st.

The waiver funds uncompensated care at the current level at \$3.1 billion each year for the first and second year of the five-year agreement. CMS has granted Texas an additional year of a transitional UC pool funding level, in light of the significant impact of Hurricane Harvey on Texas health care providers' operations and financial stability. During the first year of the extension, CMS expects Texas will work with its providers seeking to participate in the UC pool so that they accurately report the extent of their charity care in alignment with Medicare cost reporting principles.

In the third year and moving forward, CMS will transition to a new method of distributing uncompensated care payments to hospitals. The new methodology, according to HHSC, will account for all provider types and will be based upon uncompensated charity care costs.

The Delivery System Reform Incentive Payment (DSRIP) funding pool will be maintained at level funding for the first two years of the waiver extension. The DSRIP pool is funded at more than \$11 billion and will be phased out over four years under the waiver. Delivery-system reform initiatives include infrastructure development, system redesign and improvements targeting clinical outcomes and population health.

The DSRIP program will transition to a systemic effort that focuses on health system performance measurement and improvement that achieves sustainable and effective delivery system reform. In order for additional extension the State will be required to indicate how they will:

- 1. Strengthen the measurement set to include more outcome measures, assure uniform reporting on measures within bundles, and eliminate measures and bundles that are not specified.
- Define and incorporate an attribution model for beneficiaries to providers that
 reflects generally accepted standards for attribution, and assure that all of the
 beneficiaries attributed to a provider related to a particular measure be included
 in the denominators.
- Assure that the distribution of incentive funds to providers, based on their performance on a bundle of measures, is in proportion to the predetermined value of the bundle, and distribute funding within a bundle proportionately across all required measures.
- Include a suitable and accountable performance measurement and payment methodology for incentive payments for providers that have high and/or maximized performance baselines.
- Require participating providers to specify and link needed core activities to their selected bundles and measures, advance these activities, and report on their progress.

Re: (5) Tax Abatement Expiration Date

Background:

Cities, counties, and special districts can use tax abatements to help attract new businesses and retain and develop existing ones. A tax abatement is a local agreement between a taxpayer and a taxing unit that exempts all or part of the increase in the value of the real property and/or tangible personal property from taxation for a period not to exceed 10 years.

The Texas Legislature authorizes local governments to administer property tax abatements under section 312 of the Tax Code which was renewed in 1995, 2001, and 2009 to allow tax abatements through September 1, 2019.

Under current law, no abatements would be permitted after September 1, 2019, because Chapter 312 is set to expire on that date. The maximum length of an abatement is ten years.

Urban Counties is working with various stakeholders, including TAC, TML and the City of Austin to discuss options for the continuation of the tax abatement option for local governments.

In 2009 when the chapter was set to expire Urban Counties included an item of support in the Policy Platform for the extension of the Property Redevelopment Tax Abatement Act.

Re: (6) Children's Health Insurance Program Update

Background:

Federal funding for CHIP, which provides health coverage for almost 400,000 Texas children was extended in an amount of \$135 million through February 2018.

In November, the Texas Health and Human Services Commission (HHSC) had requested \$90 million from the federal government to extend the program through February.

CHIP covers prescriptions, lab tests, and doctors visits, including dental and eye care for youth ages 18 and younger, as well as prenatal care for pregnant mothers.

About 390,000 Texas children benefit from CHIP; and about 36,000 Texas women also received prenatal care and post-delivery checkups with CHIP funds.

The Texas Health and Human Services Commission (HHSC) has stated that Texas law requires termination of the CHIP program when there are no longer federal funds available.

The State is required to then provide families with a notice of termination of CHIP eligibility no later than 30 days before the date the child's eligibility terminates.

HHSC would electronically transmit the terminated children's information to the ACA Marketplace requiring parents to take additional steps to enroll their children in the ACA Marketplace.

- 11. Oppose requirements to include on bond propositions information other than the total amount of bonds to be issued if approved and the proposed uses of the bonds.

- 12. Establish that the earliest effective date for any increase in salary budgets outside the control of commissioners court shall be the first day of the next county fiscal year following 90 days notice of the proposed increase to be provided to the commissioners court.
- 13. Support continued federal funding for local communities to help cover operational costs for holding undocumented criminal aliens in the criminal justice system and the costs to house them.
- 14. Oppose restrictions on the ability of local governments to effectively and efficiently communicate with the legislature and other state and federal entities.
- 15. Support proposals to permit public access to public information on the personal devices of public officers and employees that include reasonable provisions to guard against frivolous and abusive lawsuits against public officers and employees.
