Following the motion, Judge Self said the contract for the position and the person for the position are two separate issues. The contract can be done without the addition of a person. He said never in the eleven years he has been in office has every detention officer slot been filled. The average unfilled positions per pay period this year is 14. This position is not a one-time expenditure. Personnel is different; it is permanent. He encouraged the Court to not begin budgeting like the federal government with short continuing resolutions. Once this is done it will be counted against the 8%.

Commissioner Fletcher said she understands both sides of the debate and asked the Sheriff's Office to come forward to talk about the position. Because this is a grant funded position she believes it makes sense to approve.

Terry McCraw, Assistant Chief-Jail Administrator, said all 242 jailers currently positioned and budgeted are priority. As of today, nine positions are open. He said there are six people set for interviews this week for possible job offers and three applications waiting at medical. The people who fill the SCORE positions go in knowing the position is grant funded. If funding is lost, they know they may not have a job if a detention officer position is not open.

Judge Self said there is no doubt the SCORE Program is effective, but adding a position is not necessary. The position could be added during the normal budget cycle. With no further discussion, the motion carried. (Time: 1:43 p.m.)
