Brief Description
 SCAAP provides federal payments to states and local jurisdictions that incurred correctional officer salary costs for incarcerating undocument criminal aliens with at least one felony or two misdemeanor convictions and are incarcerated for at least four days during the reporting period. Funding is calculated using a formula that provides a relative share of funding to jurisdictions that apply and is based on the number of eligible criminal aliens, as determined by the US Department of Homeland Security. SCAAP funding is restricted to correctional purposes only. Collin County has previously received \$8,418 (FY16); \$3,074 (FY15); \$16,102 (FY14); \$134,801 (FY13); \$102,223 (FY12); \$277,682 (FY11); \$410,922 (FY10); \$461,705 (FY09).
