

Commissioners Fletcher and Webb

Thank you for attending the city council meeting and presenting your plan for funding the transportation needs of Collin County. Also, thank you for partnering with Frisco for the funding of many of the thoroughfares which have been constructed in Frisco.

I respectfully request that you consider to either dedicate 25% of the suggested \$400 million bond election every 5 years to partner with cities for continued construction of the county master thoroughfare plan. As a second suggested alternative, I suggest you raise the total amount to \$500 million and dedicate 20% of the amount to the partnership with cities. Either alternative funds \$100 million for the county-city partnership program.

Your suggested 10% alternative only provides \$40 million dollars, or \$8 million per year countywide. I believe that amount is too low to be effective.

If you need any additional information, I will be glad to assist.

Hopefully, you will be able to show that the Commissioners Court remains in favor of assisting continued development of the thoroughfare network throughout Collin County.
