Stacey Kemp, County Clerk, came forward to request approval for the FY 2019 Preservation, Restoration and Records Archive Five Year Plan. Five dollars per transaction will be used to preserve documents and conduct restoration activities when necessary from the beginning of the records until the 1951-52 era. This past year Ms. Kemp's office worked on DD-214s. Once they are completed, work will begin on birth records.

Judge Self opened up the public hearing and asked for comments. Hearing none, Judge Self closed the public hearing. Commissioner Fletcher made a motion to approve. (Time: 1:44 p.m.)

Clarence Daugherty, Engineering, came forward and introduced Ceason Clemens, P.E., Director, Transportation Planning and Development for TxDOT. Ms. Clemens was present to update the Court on the US 380 Collin County Feasibility Study. There were four major tasks associated with the project: Step 1 was to develop roadway options and alignments based on initial technical analysis to share with cities, the county and the public and gather their feedback. Step 2 was to review feedback. Ms. Clemens said Step 1 is completed. Five alignments were presented to the public in April and May. Step 3 is to respond to the comments and share results with cities, the county and the public and narrow down the five alignments that we're currently looking at. And Step 4 is to work on developing a consensus on the locally preferred alignment.

Ms. Clemens showed a timeline of the feasibility study. TxDOT started looking at various developments along the corridor and through the county in June 2017. Data was gathered and five alignment options were presented to the public in April-May 2018. This summer comments and feedback were analyzed. The goal is to have two to three alignments to present to the public for additional feedback in early October 2018. And the hope is in 2019 to have a locally preferred alignment to present.

There are 15 key factors used when analyzing alignments. Among them are stakeholder and public input, engineering analysis and traffic analysis. The other factors are: safety and crash data; right-of-way requirements, existing and planned residential and commercial developments; existing and planned utilities; cost and economic impact; other planning efforts, natural and cultural resources; endangered species; land use and parkland; water resources and flood plains; hazardous materials; and social and community impacts.

Feedback from the community was important. TxDOT advertised in the paper and on social media, they worked with each city and the county and signs were placed along the corridor. Over 1,100 people attended the three meetings in April and May, and over 4,600 comments were received either at the meetings, or by email or letters. Additionally surveys were offered electronically and a paper version was available as well.

The final steps will be to complete the review of the 4,600 comments. TxDOT is looking at the traffic analysis and environmental impacts. The goal is to narrow down the five alignments to two or three. They will continue to conduct additional outreach with homeowners, neighborhoods and businesses. The next round of public meetings will be in October to show the final two to three alignments.

Judge Self commented there really is no change and everything is moving forward. Ms. Clemens replied they are targeting early October and feel they can meet that deadline.

Commissioner Fletcher is concerned about the economic impact; which homes and businesses will be taken out. She asked if that would be included in the updated presentation.

Ms. Clemens said they will show the impact to all of those. Once they have a locally preferred alternative, the next step will be to create a detailed schematic and do a detailed environmental impact.

Commissioner Thomas stated the alignments go through Precinct 3. He wanted input on the impact to the community and business, including sound walls. The Commissioner asked for an analysis of the pros and cons.

Ms. Clemens said that would all be captured in the final environmental document.

Commissioner Webb thanked Ms. Clemens for all of her work. He's most interested in the process; he wants to make sure that all the steps are followed and there are no shortcuts taken.

Judge Self stated he had a blue card from Mr. Ellison. Thomas Ellison, Farmersville, stood and said he would defer. He was present representing the City of Farmersville. They are working with TxDOT. (Time: 1:39 p.m.)
