GENERAL DISCUSSION

- 5. FY2019 Budget
- **a.** <u>AI-45482</u> Salary Grievance Committee recommendation for Justices of the Peace, Commissioners Court.

Judge Self said the Salary Grievance Committee passed a recommendation with an 8 – 1 vote for all the JPs (Justices of the Peace) to receive a 5% total pay increase – 3% already approved by the Court for Elected Officials and 2% of the 6% requested by the JPs. Because the vote was not unanimous, the recommendation is before the Court for consideration. A brief discussion ensued.

A motion was made to approve the Salary Grievance Committee's recommendation of a 2% increase above the 3% increase already approved for a total of a 5% increase. Receiving no second, the motion failed. (Time: 1:37 p.m.)

Monika Arris, Budget, came forward to present the FY2019 Proposed Budget. Ms. Arris reviewed the General Fund revenue versus expenditures. Taxes on the revenue bring in \$172.9 million in the General Fund with an additional \$30.1 million of revenue for a total of \$203 million. This is a 3.3% increase over FY2018. As for expenditures, there is \$201.6 million in regular expenditures and \$7.2 million in one-time expenditures for a total of \$208.8 million.

No taxes are collected for the Road & Bridge Fund which has a revenue of \$22.1 million and \$24.7 million in expenditures. Ms. Arris said the Fund Balance is decent, so there is no need to allocate any tax dollars to this fund which is why there are more expenditures than revenue. The Permanent Improvement Fund has a small amount of taxes in it along with a small amount of interest earnings. Taxes in this fund equal \$400,000 with \$100,000 in interest for a total of \$500,000. The Permanent Improvement Fund expenditure budget is \$2 million. Like in the Road & Bridge Fund, there is enough Fund Balance to account for not needing so many tax dollars in the Permanent Improvement Fund.

The Operating Fund is the combination of the General Fund, the Road & Bridge Fund, and the Permanent Improvement Fund. These funds receive tax dollars. The total taxes for the three funds is \$173.2 million added to \$52.3 million of other revenue for a total of \$225.6 million in revenue. This is a 1.9% increase over FY2018. Expenditures are \$228.2 million with an additional \$7.2 million in one-time expenditures which brings the total expenditures to \$235.4 million.

Looking at the Debt Service Fund, the debt payment dropped by \$19.6 million from FY2018. On September 10, 2018, the Court passed a resolution to call outstanding bonds for redemption in the amount of \$27.09 million. An additional \$18.5 million is included in the budget from the Debt Service Fund Balance to pay off the 2018 tax notes which were recently sold.

The Healthcare Fund is now supported by the General Fund. The Healthcare Fund will receive a transfer of \$1.8 million from the General Fund for FY2019. In addition to the \$1.8 million the Healthcare Fund receives \$1.3 million in revenue for a total revenue of \$3.1 million. Proposed expenditures for the Healthcare Fund is \$4.7 million.

The total FY2019 Combined Budget Revenue is \$352.1 million. The grand total of the FY2019 Expenditure Budget including the one-time expenditure is \$378.3 million.

Judge Self opened the Public Hearing at 1:43 p.m. and asked for public comments.

Alyse Ferguson, MHMC (Mental Health Managed Care), came forward to request an additional Legal Clerk I to handle the additional magistration which was approved during the Budget Workshop. The total cost for the position including salary, benefits and equipment is \$78,159. A motion was made to approve the additional Legal Clerk I. (Time: 1:45 p.m.)

7. <u>AI-45416</u> Agreement to Contribute Right of Way Funds (Fixed Price) with the State of Texas acting through the Texas Department of Transportation (TxDOT) for certain highway improvements on SH 205 from North of John King (Rockwall County Line) to SH 78 for the acquisition of certain right of way and the relocating and adjusting of utilities, Engineering.

Clarence Daugherty, Engineering, came forward and said TxDOT (Texas Department of Transportation) has a policy requesting local governments to participate in the cost of acquiring right-of-way for their projects in the amount of 10% of the total of right-of-way and utility adjustment cost. The amount in the contract for this project is \$717,427 and involves two local governments – Collin County for the unincorporated area and the City of Lavon. Lavon is asking for the County to cover their portion of the cost. Because of the past practice by the Court on similar items, this is before the Court for consideration.

Judge Self asked to hear the history of the Court on these types of items. Mr. Daugherty said from 2013 – 2017 the County has expended \$7.6 million. Of that, \$5 million has been to cover city shares on projects which have involved small cities.

Commissioner Williams said Lavon did have an obligation on SH78 which they covered and did not ask for assistance. Lavon has been extremely supportive of the County's strategic plan and bond efforts. They have also passed resolutions supporting a north/south freeway. Lavon has done everything the Court has asked cities to do in order to get assistance from the County. The Commissioner believes the Court should support the request and made a motion to approve the item.

Following the motion, Commissioner Thomas asked Kim Dobbs, City Administrator for Lavon, to explain what is affordable for the City and why this is such a constraint. He would like the City to have some "skin in the game" with the project. Ms. Dobbs said the \$89,000 seems like a reasonable amount, but that is 4% of the City's budget and is a substantial sum to include. This amount represents the salaries of two Lavon police officers. The Commissioner suggested Lavon contribute 20% of their cost with the remaining 80% covered by the County. Commissioner Williams reiterated her motion.

Judge Self asked how many small cities have passed resolutions supporting LARs (Limited Access Roadway) and the bond efforts. Mr. Daugherty believed there are a half dozen who have passed resolutions. However, there are not many resolutions on the 2018 bond program. Judge Self said as a County we need to be taking political stances encouraging the cities to support the County's long-term view.
