Proposed Project Services

1. Briefly describe the Proposed Project. Be specific in your answer and include the *Who*, *What*, *Where*, and *When* of the Project.

The North Texas Regional Veterans Court is a specialized program for justice-involved veterans (JIV) with combat-related mental impairments directly correlated to the crime with which they are charged. The program provides a second chance through a judicially-supervised, team-based approach to ensure participants receive treatment for underlying risk factors that contributed to their crime(s), including substance abuse, medical, and/or behavioral conditions. PTSD, traumatic brain injuries, and substance abuse all change the way the brain functions and impacts the ability of individuals to make responsible choices. Research has demonstrated that establishing a supportive, non-adversarial judicial relationship, employing progressive sanctions and incentives, and providing regular, meaningful involvement with a judge are significant factors leading to positive behavioral changes among offenders.

The goal of the North Texas Regional Veterans Court is to move justice-involved veterans out of the traditional criminal justice process and into appropriate, individualized rehabilitative alternatives that improve mental health and successfully lead to community reintegration and criminal case resolution. Once veterans have been screened, assessed, and approved for participation in this voluntary program, they promptly begin a treatment program that is specific to their needs. In addition to program team meetings, the program may involve drug and/or alcohol treatment, random drug testing, support group meetings, vocational or job counseling, educational classes, and community supervision. Many services are provided by outside agencies, and participants are referred as needed. While actual length varies based on participant progress, the 12-to-24 month program consists of 3 phases requiring frequent meetings with the Judge and Program Team. Upon successful completion of the program, the case(s) are normally dismissed, expunged, or never filed.

The Collin County Veterans Court program was started in 2013 by the 296th District Court Judge in Collin County. Unfortunately, many smaller counties in the area do not possess the resources to manage a similar program, resulting in justice-involved veterans in those counties not receiving the treatment and support needed for recovery and restoration to their pre-combat lives. In an effort to meet the need, the program was expanded into

four neighboring counties - Fannin, Grayson, Kaufman, and Rockwall – resulting in the North Texas Regional Veterans Court. Each county has a local interdisciplinary team, composed of a supervision/probation officer, veterans service officer, defense attorney, prosecuting attorney, and law enforcement officer, which are led by the 296th District Court Judge. The team reviews and discusses participants' progress and uses a coordinated strategy to help veterans recover. The program currently consists of 55 participants – 22 from Collin, 8 from Rockwall, 10 from Grayson, 10 from Kaufman, and 5 from Fannin County. Additional participants are expected to be added throughout the grant period.

As program success can be affected by daily life circumstances, grant funding will be used to assist veterans' with unexpected needs that are critical to the veterans' overall wellbeing such as utility, housing, and transportation expenses. Provision of assistance in these situations allows veterans to more fully participate in the program, focusing on recovery and reintegration into society. Grant funds will also be utilized to provide abstinence monitoring and calendars/journals for program participants, as well as program handbooks for participants, mentors, and Veterans Treatment Court (VTC) staff members.

Grant funding is requested for three contractual positions to serve participants in all five counties. The Program Manager serves as the primary point of contact for the VTC, receives and reviews all applications for program participation, coordinates opportunities for community outreach and program education, oversees all program participants and staff, coordinates between the counties, collects and maintains all program data, and updates the programs policies and procedures to remain current with the best practices of a VTC. The Licensed Mental Health Consultant will complete initial evaluations for participants, contribute to the development of individualized treatment plans, monitor progress, and make continuing care recommendations. The Case Manager will serve as the veterans' first point of contact on the VTC treatment team and link participants to the civilian continuum of care, providing community linkages and referrals, as appropriate, and will aid in monitoring program compliance. Travel monies will be utilized by the Judge for travel between the counties and for attendance to the annual Texas Association of Specialty Courts Training Conference. Additionally, funds to compensate reserve bailiffs needed for court sessions in Grayson and Rockwall counties and court reporters in Fannin, Grayson, Kaufman, and Rockwall counties are being requested. Court sessions in Rockwall County are held in an auxiliary courtroom and a bailiff is not provided.

2. Briefly describe how Beneficiaries will access and/or be provided with Project services by your organization. Be specific in your answer and include the How of the Project.

The North Texas Regional Veterans Court will operate as most treatment courts with a court team overseeing an intensive supervision program with strong judicial interaction. Judge John Roach, Jr., will preside over the program for all five counties. The three proposed grant-funded positions - Program Manager, Licensed Mental Health Consultant, and Case Manager – as well as the US Department of Veterans Affairs (VA) Veterans Justice Outreach Specialist will serve on all counties' teams. All other members will only serve their respective county's participants.

Prior to program admission, North Texas Regional Veterans Court candidates will be evaluated by the proposed Licensed Mental Health Consultant. The court team does not currently have a single mental health professional that is an active and consistent participant in all counties and court sessions. If the candidate is accepted into the program, the Licensed Mental Health Consultant will use the evaluation findings to design individualized treatment plans in coordination with the veteran. The VA Veterans Justice Outreach Specialist, proposed Case Manager, and the Program Manager will coordinate to formulate goals, assign the veteran to treatment programs, consult with clinical staff for co-morbidity treatment, and coordinate with partner agencies for any additional needs.

Treatment is usually provided at no charge through the VA. However, some veterans have needs beyond the scope of VA counseling programs or are unable to obtain transportation to the nearest VA clinic. The proposed Case Manager will be the veterans' link to the civilian continuum of care by providing community linkages and referrals and assisting with navigation through the civilian healthcare system. Additional treatment and counseling, such as equine therapy, family counseling, etc., will be performed by partner agencies and private practitioners. Mid-point evaluations will be conducted by the Licensed Mental Health Consultant to assess treatment progress and make adjustments as needed.

Additionally, during the initial program phase (approximately 3-4 months), participants may need to be equipped with a SCRAM (secure, continuous remote alcohol monitoring) device, drug patch, or other monitoring device to monitor abstinence and promote substance-free living while they progress with counseling and treatment. Grant funds will be used to defray abstinence monitoring costs for veterans who are unable to afford the monthly service costs.

As program success can be affected by daily life circumstances, the program also provides or assists with provision of other needs and services to help participants succeed on a case-by-case basis. The program works to meet a veteran's emergency situation needs on an individualized basis while developing a long-term plan for the veteran to succeed on his/her own. The Case Manager provides community linkages and referrals to appropriate agencies/organizations for support services and coordinates with the Program Manager to assist with any emergency needs, which can include, but are not limited to, transportation, utility, or housing assistance and interview appropriate clothing. The Program Manager arranges services paid with grant monies and manages the grant funds, which are paid directly to the service provider, as opposed to the veteran themselves.

In addition to the aforementioned services, participants are also provided with a mentor. Mentors have routine contact with participants and attend court sessions with them. The majority of mentors are veterans themselves, and as such, provide an additional person, outside of the system, for the veterans to communicate with, relate to, and form bonds. In many instances, this relationship lasts beyond the length of the program. Each county has a mentor coordinator tasked with recruiting and assigning mentors for program participants.

While the program length varies (12 to 24 months) for each individual participant and their needs, it consists of three phases requiring less frequent monitoring and supervision with each subsequent phase. For each county, the court team will meet monthly to review and discuss each participant's program progress. Reports can cover a range of topics including employment, rule violations, drug/alcohol screening results, and treatment, among others. Any failure to comply with program requirements is addressed and progressive sanctions, based on a written matrix, may be imposed. If all reports are positive, the participant receives encouraging feedback and may look forward to program advancement and completion.

Need Identified

1. What is the community need(s) or existing service gap(s) that the Proposed Project will address? More than 20 million men and women living in the US have served in the US military. Many of these veterans were deployed to engage in combat operations, spending long periods being hyper-vigilant in high stress situations. Combat zone duty can result in injuries both to the body and psyche including post-traumatic stress disorder (PTSD), traumatic brain injuries (TBI), orthopedic injury and/or amputations, which are all conditions that can derail emotional control and lead to interpersonal conflicts and/or other erratic behaviors resulting in job loss, divorce, and strained relationships. Unfortunately, decades of research has shown that veterans can have a difficult time of readjusting to civilian life and have been shown to have higher than normal prevalence of mental health and substance abuse issues, which frequently result in illegal, violent, and/or risky behaviors; increased contact with the criminal justice system; and incarceration.

According to the US Census Bureau 2016 Quick Facts, nearly 68,000 veterans reside in the five counties that make up the North Texas Regional Veterans Court. In Collin County, the number of veterans has decreased over the past 8 years by 4%; however, the number of veterans jailed has significantly increased.

2. How did you identify the community need(s) or problem(s)? Be specific in your answer and sufficiently describe any methods used to identify that the need described above in **Need Identified #1** is present in your service area. Include references to data that may substantiate and support that this need exists in your service area. With the ongoing Middle East conflicts, Judge Roach, in his 296th District Court, noticed an increase in veterans being charged with crimes that were directly related to their military service, evidencing a need for a veteran-specific treatment court. In Collin County, over the past 8 years, the number of inmates with military experience has

increased almost 400% from fiscal year 2010 to 2017. Data is expected to be similar from other counties participating in the North Texas Regional Veterans Court based on anecdotal evidence.

The benefits of program expansion were initially recognized by the Veterans Service Officer through networking avenues. Many of the smaller counties in North Texas are unable to support a veterans treatment court program, leaving the justice-involved veterans in those counties without the support and treatment needed to recover. Understanding that a regional court would be able to reach more veterans by having smaller counties coordinate with larger counties to maximize resources in North Texas, Judge Roach offered to create and preside over a regional program. Establishing a regional court brings this valuable program and its potential benefits to veterans outside of Collin County.

3. How will the Proposed Project address the identified need(s) or problem(s)? Similar to other drug or treatment courts, the North Texas Regional Veterans Court utilizes a judicially-supervised, multi-agency team-based approach to serve veterans struggling with addiction, mental illness, and other underlying risk factors that contributed to their crime(s). The voluntary program requires participants to undergo intensive treatment and counseling, submit to frequent supervision and random alcohol and/or drug testing, make frequent appearances in court, and to be closely monitored for program compliance. Promotion of sobriety, recovery, and stability through individualized substance abuse and mental health treatment and counseling, coupled with connections for housing, medical, vocational, and other support issues, diverts military offenders away from the traditional criminal justice system and attempts to reduce recidivism through provision of services while holding offenders accountable for their actions and addressing the underlying issues related to their criminal behavior.

The North Texas Regional Veterans Court taps into the unique aspects of military and veteran culture and uses it to the benefit of the veteran. Through the program, former military personnel are allowed to participate in the treatment court process with their fellow veterans, re-instilling a sense of camaraderie that they felt while in the military, and providing them with the treatment and tools for coping with their underlying problems. As the program comprises five counties, more justice-involved veterans are able to participate in this successful treatment model, which otherwise would be unavailable to them based solely on county lines.

The proposed project provides financial assistance for abstinence monitoring and emergency living assistance for program participants, as well as funding three consultant positions who provide services crucial for veterans' success through the program.

4. How is the Proposed Project unique from other similar services that may be available in your proposed service area? Be specific with details about what sets your Proposed Project apart.

The North Texas Regional Veterans Court, judicially supervised by the 296th District Court, was the first regional veterans treatment court in Texas and is the only veterans treatment court in these five counties. The purpose of the program is to provide veterans with individualized rehabilitative alternatives that successfully lead to community reintegration and criminal case resolution. While there are other drug / treatment courts in the counties, there aren't any that specifically target veterans and their specialized needs. The Veterans Court team is composed of persons who can coordinate veteran-specific treatment and benefits and whom, as mostly veterans themselves, are better equipped to mentor justice-involved veterans. The regional program is able to reach veterans in multiple counties that otherwise, based on county lines, would not receive the support and treatment needed for recovery and restoration to their pre-combat lives.

Successful completion of the program will be determined by maintaining and analyzing the number of participants who complete the program against the number who begin the program. Additionally, the Program Manager will search county arrest / jailing records and conduct a personal follow up with program graduates at one year post-completion to determine if the veteran has reoffended. Post-program data will also be collected by the Mentor Coordinator through direct contact with program graduates, whose goal is to maintain contact for at least three years post-program completion. Cohen Military Family Clinic, and the VA Community Based Outpatient Clinics provide individual and group counseling, intensive outpatient treatment, and integrated, client-centered outpatient mental health care for participants, as needed for recovery. In many cases, services are provided at no cost. Equest and Jake E's Riding Round Up provide equine assisted therapy, which can be important for some veterans' recovery, generally at no cost. Green Path Financial Wellness provides financial / budget counseling and classes at no cost to program veterans. Legal Aid of North West Texas provides no or low cost legal advice for a wide variety of legal issues with which program participants are struggling. Military Veteran Peer Network provides mentors for each participant, which has proven beneficial to participant success. Recovery Healthcare Corporation and Smart Start provide alcohol and/or drug monitoring for participants to reduce substance abuse and ensure program compliance. Outreach activities include continued information dissemination (“news flashes”, blogs, posters, and oral presentations) in participating counties to veteran-specific organizations, community service organizations, and legal defense representatives/bars. Additionally, staff persons in each county’s District Attorney and Sheriff’s Offices serve as Veterans Court team members and screen for justice-involved veterans coming through their offices.

 FVA funding will allow veterans to obtain services, such as evaluation, alcohol monitoring, and emergency support, which may otherwise be unable to be funded by the veteran preventing some from participating in the program. Without FVA funding, emergency support and needed treatments outside of the VA system will be limited. However, the North Texas Regional Veterans Court will continue to operate through staff salaries, participant fees, and retained fees collected in accordance with Chapter 102.0178, Code of Criminal Procedure, for offenses found in Chapter 49, Penal Code (DWI) and Chapter 481, Health and Safety Code (controlled substances). Additionally, the program will continue to coordinate with existing partners.

Without grant funding, the contractual positions will either be terminated or Collin County may consider adding employee positions. Termination of the positions will likely result in a reduction of the number of participants the program can manage.

The Judge, who is based in Collin County, will be required to attend Veterans Court sessions in participant counties in the North Texas Regional Veterans Court. Weekly travel will be reimbursed at the IRS reimbursement rate and will average 121 miles each week for 51 weeks (121 miles x 51 weeks x \$0.535 per mile ≈ \$3,300).

The Judge will attend the Texas Association of Specialty Courts (TASC) training conference April 10-12, 2019, in Galveston, TX. This three-day event provides resources and training and creates a forum for dialogue on current issues facing treatment courts in Texas. Registration \$240, lodging, \$180/night for 2 nights including parking, airfare/transfers or mileage reimbursement (location dependent) \$500, and meals \$150 = \$1,250.

Basic consumable office supplies will be necessary to perform basic administrative duties. The estimated cost of \$300 was based on previous annual expenditures for program administrative supplies.

Journals, calendars, and program handbooks will be provided to each participant upon program entry. Journals are beneficial for the veterans to have a specific place to write things down, enabling them to better remember and address things as needed. Calendars help the veterans keep track of the many medical, probation, counseling, and other treatment or support appointments; missed appointments can lead to program termination. Participants bring their journals and calendars to court, referring to them when addressing the Judge during court sessions. Program handbooks are provided to all new program participants, mentors, and staff members and detail the policies, procedures, and structure of the program, as well as the requirements for each program phase, promotion, and graduation. Calendars and/or journals will be purchased for 50 veterans at \$13 each (50 participants x \$13 = \$650). Handbooks will be purchased for 50 veterans and 20 mentors or staff members at \$10 each (70 persons x \$10/handbook = \$700).

Abstinence monitoring helps prevent substance abuse allowing the veteran to focus on counseling/treatment and recovery. Additionally, monitoring can help identify areas of concern and more quickly implement and/or modify treatment plans, as needed. Monitoring costs approximately \$10.40 per day, and most participants need monitoring services for approximately 100 days (\$10.40/day x 100 days = \$1,040/participant) for 30 participants for a total cost of \$31,200 (\$1,040 x 30).

Program success can be affected by daily life circumstances. Veterans who have housing, employment, and transportation issues may be unable to fully participate in the program and focus on recovery and reintegration into society while worrying about daily, life expenses. The program works to meet a veteran's emergency situation needs on an individualized basis while developing a long-term plan for the veteran to succeed on his/her own. Emergency living assistance (rent/mortgage, security deposit, utilities, phone, interview appropriate clothing, transportation passes), based on prior payments made by the program, is estimated to be approximately \$3,000 per veteran. We anticipate providing emergency assistance to 10 participants for a cost of \$30,000 ($\$3,000 \times 10$). All approved assistance will be paid directly to the vendor – no funding will be provided directly to clients

Counseling is typically provided at no cost from the VA and other program partners; however, transportation barriers may exist and/or the counseling program(s) needed may not be adequate or available at the VA. Counseling and treatment provides veterans with the guidance and support of experienced therapists and evidence-based techniques that address underlying issues, develop coping strategies, and/or improve behavioral/mental health. Outside counseling and treatment can range from \$250 per person to approximately \$1,500, with the average being \$1,000 per participant. We anticipate providing community-based counseling for 20 participants for a total cost of \$20,000 ($\$1,000 \times 20$).

In Rockwall County, the Veterans Court sessions are held in an auxiliary courtroom, and bailiffs are not provided. County reserve bailiffs are utilized to provide services at a cost of \$75 per half day. Veterans Court sessions are held once per month ($\$75 \text{ bailiff fee} \times 12 \text{ months} = \900).

In Fannin, Grayson, Kaufman, and Rockwall counties, a court reporter is needed to transcribe the participant's plea. Each county has been utilizing existing court reporters for the service when they are available. However, on occasion, there are no available court reporters and one needs to be hired for the plea. The cost for reporting services is \$200 per half day. Based on previous experience, we anticipate needing to hire a court reporter for 10 court sessions ($\$200 \times 10 \text{ sessions} = \$2,000$).

The Program Manager will have a home office, be available by phone and e-mail on a consistent basis, and be available to travel to the different counties during the week to speak with potential service and education partners, court staff, veterans groups, and program participants when the need arises. This position will be responsible for intake and interview of each interested or referred veteran, will assist with program eligibility determinations, and will provide education about the program for attorneys, family members, stakeholders, and the general public. The Program Manager serves as the primary point of contact for all things related to the program, including filtering and assessing all questions, issues, and requests by each VTC team and the public. This position will also guide the Case Manager and provide community linkages and referrals to appropriate agencies/organizations for support services and assist with any emergency needs, such as housing and transportation, which may arise for program participants. The Program Manager will coordinate with county stakeholders and Veterans Court team members in all participating counties, travelling with the Judge to all court sessions, community engagements, and VTC training events. The position will work with participating counties to schedule court, maintain a schedule of appearances, and complete reports and reporting requirements. The Program Manager gathers, assesses, and securely stores all data pertaining to program participants in order to accurately report program statistics. This data, without PII, will be analyzed and reported with the participants' knowledge and signed release and will be used in ongoing assessment related to the best practices of a VTC. The value (\$76,250) was determined based on the county's practice of grading positions based on duties and responsibilities, including travel and business expenses, and conducting comparable salary surveys for market pricing.

The Case Manager will have a home office and will be available by phone and email on a consistent basis. This position will be the veterans' link to the civilian continuum of care. The court team currently has a social worker assigned by the Department of Veterans Affairs. However, participants are not required to seek care solely through the VA health care system, and navigating the civilian health care system can be quite cumbersome for someone without the appropriate skills. This Case Manager will serve as a primary point of contact for each veteran, will provide community linkages and referrals to appropriate treatment providers, will aid in monitoring probation and program compliance, including treatment attendance and substance abuse screening, and will randomly

conduct individual meetings with participants for status checks and to maintain “unit cohesion”. The Case Manager will receive updates on participants’ treatment status from providers located outside of the VA healthcare system. This position will travel with the Judge to all court sessions and annual training conference and is expected to travel, when necessary, to meet with participants for status checks. The value (\$53,450) was determined based on the county’s practice of grading positions based on duties and responsibilities, including travel and business expenses, and conducting comparable salary surveys for market pricing.

Currently, the program’s mental health evaluation function is handled on an as need basis by various licensed practitioners. Adding a single, part-time Licensed Mental Health Consultant to the team to serve all five counties will provide a more consistent and personalized approach for the veterans. This position will attend all court sessions with the Judge, will complete the initial psychological evaluations for program participants to determine if the medical condition was a result of military service, make treatment recommendations, and will assist the Program Manager in collecting, analyzing, and securely storing treatment data for ongoing evaluation into how best to serve participants suffering from PTSD, TBI, substance abuse, and other mental health issues as a result of military service. The position will monitor overall treatment progress given by other providers and recommend adjustments, as needed. Additionally, the part-time Licensed Mental Health Consultant may conduct mid-point evaluations or crisis evaluations when required. This position will supply his/her own computer, phone, and office supplies. As the Licensed Mental Health Consultant does not provide counseling/treatment for VTC clients, participants not utilizing grant funds (those with full-time employment) are responsible for paying for all or part of their own counseling/treatment and abstinence monitoring, when possible. Additionally, participants are charged a sliding-scale fee, up to \$1,000, to participate in the program, and the county retains a portion of the fees collected in accordance with Chapter 102.0178, Code of Criminal Procedure, for offenses found in Chapter 49, Penal Code (DWI) and Chapter 481, Health and Safety Code (controlled substances). These funds are placed in the respective county's treatment court fund, and are used to pay for program needs that participants cannot afford. Staff salaries are paid for either by the county or by the employee's respective employers for non-county employees. Substance abuse testing supplies and lab services, as well as SCRAM devices for non-pretrial diversion participants, are paid for by the supervision and corrections department.
