GENERAL DISCUSSION

Commissioner Webb said there was a discussion about the proposed Volkswagen Settlement proceeds plan at the last RTC (Regional Transportation Council) meeting. The state is to receive \$209 million and the TCEQ (Texas Commission on Environmental Quality) has planned how it intends to allocate the funds. It became clear that the metroplex will not be getting a fair share of the proceeds. As a result, the RTC authorized a letter to the TCEQ stating they would like to see a fair allocation of the proceeds. The City of Dallas is also sending a letter. The Commissioner submitted a letter opposing the plan to the Court for consideration. A motion was made to approve a letter opposing TCEQ's Settlement Draft Beneficiary Mitigation Plan with the option of Judge Self signing on pending his approval.

Following the motion and second, Commissioner Thomas said he is concerned with the NCTCOG's (North Central Texas Council of Governments) idea on how the money should be used. He does not support it and said Collin County should have its own way of deciding how to use the funds. With no further discussion, the motion carried. (Time: 6:07 p.m.)
