Commissioner Fletcher led the Invocation.

1. Judge Self called to order the meeting of the Collin County Commissioners' Court at 1:30 p.m. and recessed the meeting at 1:56 p.m. The meeting was reconvened and immediately recessed into Executive Session at 1:57 p.m. The meeting was reconvened at 2:10 p.m. and adjourned at 2:11 p.m.

President Self called to order the meeting of the Collin County Health Care Foundation at 1:56 p.m. and adjourned the meeting at 1:56 p.m.

2. Public Comments.

Brian Loughmiller, former Mayor of McKinney, came forward to publicly recognize members who served on the Transportation Bond Committee. They are Paul Wageman, Committee Co-chair, Anita Collins from Wylie, Terri Green of Frisco, Wylie Mayor Eric Hogue, David McCall from Plano, Adam Majorie, Bill Moore, Mark Reid, Randall Shinn, Sal Carroll, Corbett Howard, Rusty Glover, Shep Stahl, and Ron Leach. The committee met every Monday until the night before the election and made over 30 presentations to various organizations, city councils and chambers that would be affected by the bond election. The presentations addressed the soft costs and timelines for the next five years, and they made sure cities understood the 50% match required on the regional thoroughfares. James Mosser, an attorney in Plano, came forward to address the Court regarding the Dallas News article about this attorney's billings. Mr. Mosser stated he does not know the attorney but feels the commentary in the article was unfair and irresponsible to the attorney. People don't understand what lawyers do in indigent defense. Commissioner Fletcher explained that Commissioners' Court does not set the attorneys' rates for indigent defense, but the Court does have a fiduciary responsibility for public dollars. Commissioner Williams said Commissioners' Court has asked the administrative judge to sign off on the payments in addition to the presiding judge, but this has not been done. (Time: 1:44 p.m.)

GENERAL DISCUSSION

5. <u>Al-33858</u> RTC monthly update, Commissioner, Precinct 4.

Commissioner Webb updated the Court on the last RTC (Regional Transportation Council) board meeting. The first item of interest was the adoption of regional performance measure targets which was required by the federal FAST (Fixing America's Surface Transportation) Act. The targets were set in cooperation and coordination with TxDOT (Texas Department of Transportation). Almost 70% of all the off-system roads in the State of Texas are in poor condition, while only 18% of on-system roads are in poor condition.

The next item was the 2018 MPO (Metropolitan Planning Organization) Milestone Policy which affected projects that have been funded ten or more years but had not proceeded to construction. Thirty-seven projects did move forward, but three projects in the metroplex did not. The recommendation was to extend the deadline one more year. If there is no progress by that time, the funding is gone for those projects. None of the projects are in Collin County.

The RTC is moving forward with its legislative agenda which is similar to what it was last session. Another item of interest was Michael Morris and his team were in Washington meeting with the Federal Highway Administration regarding several options to implement improvements on the HOV (High Occupancy Vehicle) lanes on US75. They are looking to resolve this within the next 90 days.

The last item is they are moving forward with the planning for the Fort Worth to Laredo high-speed corridor. This will go from Fort Worth, Waco, Temple, Austin, San Antonio and then Laredo. The Dallas and Houston high-speed corridor is moving forward rapidly. (Time: 1:54 p.m.)
