**3.** <u>AI-44504</u> Specifically prohibit recipients of Health Care Services grant agreements from providing or making referrals for abortions, Commissioner Precinct 3.

Trustee Thomas said there is a gap in the requirements for the grant agreements which should prohibit the recipients of Health Care Services grants from providing or making referrals for abortions. These should not be supported by the County. Trustee Williams is in full support of adding this into the grant agreements.

With no further discussion, a motion was made to specifically prohibit Health Care Services from receiving grants from the County if they make referrals for abortions or provide abortions. The Court asked Candy Blair, Health Care Services, to bring back language to that effect in a formal document. (Time: 1:36 p.m.)
