Commissioner Webb pulled this item and said the Court needs to amend its policies related to taking on the maintenance of additional roads. The County will have to maintain these roads until they become part of a city. This is an expenditure that Commissioner Webb feels strongly that the County should not continue to sponsor. Commissioner Fletcher concurred with the Commissioner's concerns.

Tracy Homfeld, Engineering, said they are in the process of updating subdivision regulations. Commissioner Fletcher said the changes in annexation law are much more restricted for a city to annex. If cities are not able to grow in the manner they have in the past, this will be a burden on the taxpayers and the budget.

Ms. Homfeld said they were directed to talk to the Planning Board about this. After the discussions, the Board voted to not have a private road policy. This decision was going to be brought to the Court along with the new subdivision update. Ms. Homfeld said they could draft something that is more along the lines of a discussion item and talk about options in the subdivision regulations. Private roads approved through subdivision regulations would continue to be built to County standards.

Judge Hill asked Ms. Homfeld to expand on the Planning Board's decision to not have a private road policy. Ms. Homfeld said they discussed options for public and private roads. The Board decided it did not want to have a policy that directed all of the new county roads to be private. The Board supports the continuance of the County accepting those new roads as public roads.

Commissioners' Court Meeting Minutes January 7, 2019 Page 7 of 10 Judge Hill does not concur with Commissioners Webb and Fletcher and does not believe the annexation issue is germane to this issue. County roads have never been held simply as being pre-city streets. Maintaining county roads is an inherent purpose of county government. The Judge said the County has the responsibility to service all the citizens of the County including those who do not live in the large cities. Judge Hill will not support that amendment to the subdivision regulations. Commissioner Webb would still like to have this issue on the agenda.
