ORDER SETTING SALARY OF OFFICAL COURT REPORTER OF THE 416TH JUDICIAL DISTRICT COURT FOR FISCAL YEAR 2019

BE IT REMEMBERED that on the 6th day of February, 2019, the District Judges in and for Collin County, Texas, considered the matter of setting the salary of the Official Court Reporter for the 416th Judicial District Court, the Honorable Andrea Thompson presiding.

WHEREAS, the salaries of official district court reporters are to be set by the District Judges pursuant to Gov. Code, Sec. 52.051.

IT IS THEREFORE ORDERED that effective February 25, 2019, DESTINY MOSES shall receive as compensation for the performance of her duties as the Official Court Reporter for the 416th Judicial District Court, the sum of One Hundred Twelve Thousand Nine Hundred Sixty-Four Dollars and Forty-Three Cents (\$112,964.43) annually; which sum of money shall be paid to her in equal bi-weekly installments from the General Fund of Collin County, Texas.

FURTHERMORE, the District Judges hereby agree that in addition to the above-stated salary, said employee shall receive any and all other benefits authorized by the Commissioners Court for fiscal year 2019, including any longevity pay in accordance with the Collin County Longevity Policy (Commissioners Court Order No. 2007-1155-12-18).

IT IS ORDERED that the District Clerk shall certify this Order to the Commissioners Court of Collin County, Texas for compliance therewith.
