2. Revisions to the CCOL SBFR for EBFR Improvements Proposed by the Cambridge Group: Revised sheets 72, 99, 110, 119 and 243. \$ (39,994.83)

Miscellaneous quantities for flowable backfill, additional concrete and removal of temporary asphalt pavement, flexbase and striping due to pending CCOL EBFR construction schedule. Increased 24" white striping quantity. Revised Sheets 99 and 111. \$ (44,740.47)
