Notice of Public Hearing

Legal Notice is hereby given that a Public Hearing will be held in regards to the Revisions to the Collin County Thoroughfare and Transit Plan.

Since the adoption of the Update to the Thoroughfare and Transit Plan (Plan) in 2014, it has been determined that the Outer Loop will not be a Tollway, but will be developed as a Freeway. The Plan must be changed to reflect this decision. In addition it has become apparent that the alignment of some of the future major thoroughfares shown in the Plan need to be changed to minimize future congestion. Finally some minor streets are proposed to be removed as well as designations of several thoroughfares are proposed to be changed.

On March 18, 2019, at 1:30 p.m. the Collin County Commissioners Court will hold a public hearing and consider approval of the Revisions to the Collin County Thoroughfare and Transit Plan. The address of the Public Hearing is Collin County Commissioners Court, Collin County Administration Building, 2300 Bloomdale Rd., Suite 4192, McKinney, TX 75071.


