ORDER APPOINTING INTERIM COUNTY AUDITOR

BE IT REMEMBERED that on the 18th day of March, 2019, the District Judges in and for Collin County, Texas, considered the matter of appointing an interim county auditor.

WHEREAS, Collin County Auditor Jeff May has submitted to the district judges notice of his intent to resign his office effective March 22, 2019; and

WHEREAS, the appointment of a permanent replacement for Mr. May will be a deliberative and protracted process;

WHEREAS, in order to efficiently and properly administer the daily functions of the office of the Collin County Auditor, it is necessary that an interim auditor be appointed until a permanent replacement has been found;

WHEREAS, Linda Riggs, First Assistant County Auditor, meets the statutory qualifications to serve as Collin County Auditor;

IT IS THEREFORE ORDERED that Linda Riggs, effective March 25, 2019, is appointed by the district judges as the interim Collin County Auditor, with all of the appurtenant powers, privileges, and obligations of that office.

IT IS ALSO ORDERED that the District Clerk shall record this action in the minutes of the district courts and certify this Order to the Commissioners Court of Collin County, Texas.
