7. AI-44358 Conference of Urban Counties Update, Commissioner, Precinct 1.

Commissioner Fletcher attended a policy committee meeting in Austin. CUC (Conference of Urban Counties) is working on a comprehensive list with a target date of the end of June, first of July to get a report on all the bills

they are tracking. Currently there are 1,555 bills waiting for signature. They are due for signature on June 16th, which they are referring to as the Father's Day Massacre. CUC is tracking 591 of those bills.

Moving on to unpaid taxes, Commission Fletcher believes that has already been signed by the governor. If someone challenges their tax appraisal, we could be in jeopardy. If we have a commercial property that comes in and challenges their appraisal, especially if they do it over multiple years, there should be a provision that we can collect something. Judge Hill asked about the taxpayer, if they are challenging their new appraisal, they would not have to make any remittance on the new tax until the matter is adjudicated. Penalties and interest would not begin accruing until the matter is settled. Commissioner Fletcher is concerned about large commercial properties. Judge Hill said with a large commercial property, taxes are not likely to go backwards, so from a budget standpoint he wondered about the County's ability to move forward. Commissioner Fletcher added it may be something that we have to look at setting up a reserve fund.

There is a big change in the house budget regarding judicial pay. Our County Court at Law judges' salaries have continued to climb. And we've been capped on the district judges' level because of the \$18,000 we've put in as an addendum to their state provided salary. Some of the funding mechanisms have changed including longevity portions. (Time: 1:43 p.m.)
