The location-level invoice automatically adjusts to provide the most accurate valuation of print titles by location in a given month.

___OPTION C: Fixed Value By Location. LMA values are established at the inception of the LMA at the location-level based upon the total library valuation at the beginning of the LMA. These amounts are fixed during the term of the LMA. If changes to the underlying library print titles subscriptions occur, charges are NOT adjusted at the location level.
