Hi Kathy,

It's that time of year that we submit to the state confirmation of voter registration activity so that the state can calculate how much money to add to our Chapter 19 Grant Fund. This year's calculation shows we will be receiving \$35,001.75 on June 1, 2019. Our current Chapter 19 fund balance is \$91,367.27. (see attached). Our fund balance after June 1, 2019 will be **\$126,369.02**.

As you may recall, the amount deposited in Chapter 19 is much higher on even numbered years because in even years we get paid .40 for each registered voter. On odd numbered years, we get paid .40 for new registered voters only. Following are the Chapter 19 amounts deposited by the state in previous years:

2020 - \$200,000.00 (*my estimate of deposit amount for June 1, 2020*)  
2019 - \$35,001.75 (will be deposited June 1, 2019)

2018 - \$190,610 .70  
2017 - \$38,921.95  
2016 - \$182,383.79  
2015 - \$22,493.15  
2014 - \$162,989.95
