This amendment ("Amendment") is effective as of the date of signature of the last party to sign as indicated below ("Amendment Effective Date"), by and between Tyler Technologies, Inc. ("Tyler"), a Delaware corporation, and Collin County, Texas ("End User").

WHEREAS, Tyler and End User are parties to a certain End User License Agreement and Professional Services Agreement dated January 10, 2012 ("Agreement"); and

WHEREAS Tyler and End User desire to amend the Agreement to add the Licensed Software, associated maintenance and support and professional services as detailed on the attached <u>Amendment Exhibit 1</u>.

NOW THEREFORE, in consideration of the foregoing and of the mutual covenants and promises set forth herein, Tyler and End User agree as follows:

- 1. The Licensed Software, maintenance and support and professional services identified on Amendment Exhibit 1 are hereby added to the Agreement.
- 2. The License Fees identified on Amendment Exhibit 1 will be invoiced 100% on the Amendment Effective Date.
- 3. Annual maintenance and support fees as set forth on the Amendment Exhibit 1 will be invoiced on a prorated basis beginning on the Amendment Effective Date and continuing through the end of End User's current maintenance term. Subsequent maintenance and support fees shall be due annually in advance at Tyler's then-current rates.
- 4. The professional services set forth in Amendment Exhibit 1 shall be billed on a fixed fee basis when all such services have been delivered.
- 5. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement.
