The Commissioner is supportive of this because these are people who are highly specialized in programming, and it is difficult to find qualified people to fill these positions. The H-1B visa is nontransferable. This means, if the County funds this, the employee can only work for the County. It is

the next part of the process that the Commissioner is concerned about. After the H-1B visa is the green card, and this would allow them to work anywhere. The green card is substantially more expensive than funding for the H-1B visa. When it comes time for the County to sponsor one or both of these individuals for a green card, Commissioner Webb would like to request a contractual agreement with them to work for the County for a specified amount of time. Judge Hill asked Cynthia Jacobson, Human Resources, if it is customary for the employer to pay for the green card. Ms. Jacobson said the employees will need a sponsor for the green card, but she is not sure if the County would be required to fund it. Typically, it is an employer expense. a AI-47069 Public Hearing - Proposed FY 2020 Tax Rate, Budget.

Monika Arris, Budget, came forward with a PowerPoint presentation on the proposed FY2020 Tax Rate. The 2019 certified adjusted taxable value is \$147.1 billion which equates to a 7.1% increase from the 2018 tax year. Ms. Arris explained the truth-in-taxation calculations. The effective tax rate is a hypothetical property tax rate which would give the County the same amount of total revenue it had in the previous fiscal year on properties taxed in both years. This year's effective tax rate is \$0.174951. The operations effective tax rate is a hypothetical property tax rate that would give the county the same amount of operating revenue it had in the previous fiscal year. This gives the county the ability to set the debt service tax rate at the amount needed to meet our financial obligations. This year's operations effective tax rate of \$0.123117. If appraised values go up, the effective tax rate goes down and vice versa.

The rollback rate is a calculation which splits the tax rate into two separate components – maximum operating rate and debt tax rate. The rollback rate allows the County to raise the same amount in operations as in the prior year plus an additional 8% allowed by law. The maximum operating tax rate of \$0.132966 added to the debt tax rate of \$0.052000 gives this year's total rollback rate of \$0.184966. The operations effective tax rate plus the required debt

rate would equate to \$0.175117. The operations tax rate after meeting our debt obligation would equate to

\$0.122951.

The current tax rate is \$0.180785 per \$100 valuation and the FY2020 proposed tax rate is \$0.174951. There has been

no tax rate increase for twenty-seven years. FY2020 would be the twelfth year for the 5% homestead exemption.

The average home value in Collin County for the 2019 tax year is \$374,658. With the effective tax rate and a 5%

homestead exemption, the average homeowner will pay \$622.69.

The next step is to file and post the proposed budget on the County's website. The public hearing on the budget is

scheduled for Monday, September 16, 2019, at 1:30 p.m. in the Jack Hatchell Administration Building,

Commissioners Courtroom. After the public hearing, the Court will adopt the FY2020 budget, tax rate, elected

officials salaries and fee schedule.
