

## EXHIBIT C

### INTERLOCAL COOPERATION AGREEMENT

#### FOR LAW ENFORCEMENT SERVICES

This EXHIBIT C is incorporated into the Interlocal Cooperation Agreement for Law Enforcement Services between Collin County (“**County**”) and Collin County Water Control and Improvement District No. 03 (“**CCWCID**”) effectively dated October 1, 2017, as amended by First Amendment to Interlocal Cooperation Agreement for Law Enforcement Services dated as of October 1, 2019 (collectively, the “**Agreement**”), and has the same force and effect as if originally written into the text of the Agreement.

Under the Agreement, County will purchase and provide the Patrol Vehicle to provide law-enforcement services to the patrol district in which CCWCID is located. Depending on circumstances, County may buy and dedicate a replacement or new Patrol Vehicle in addition to the initial Patrol Vehicle (as defined in paragraph 2.7.a of the Agreement).

CCWCID will reimburse County for one-half of the full cost of the initial Patrol Vehicle and one-half of the annual salary for the dedicated deputy. CCWCID will pay the following reimbursement amounts in eight (8) equal quarterly payments:

**For October 1, 2017 thru September 30, 2019 the following shall apply:**

<b>Patrol Vehicle</b>	$\$68,496 / 2 = \$34,248.00 / 8 \text{ quarters} =$	$\$ 4,281.00 \text{ per qtr}$
<b>Deputy Salary</b>	$\$76,377 / 2 = \$38,188.50 / 4 \text{ quarters} =$	$\$ 9,547.12 \text{ per qtr}$
	Total =	$\$13,828.12 \text{ per qtr}$

**Each of the eight (8) quarterly payments will be = \$13,828.12.**

Payment will be due on the last day of the first month of each quarter, commencing on October 31, 2019, pursuant to the following schedule:

The deputy performing under this Agreement will be paid as a starting deputy at the salary set forth above.

**For October 1, 2019 thru September 30, 2020, the following shall apply:**

**Deputy Salary**             $\$80,969.20 / 2 = \$40,484.60 / 4 \text{ quarters} =$     **\$10,121.15 per qtr**

Total =                    **\$10,121.15 per qtr**

**Each of the four (4) quarterly payments will be = \$10,121.15.**

Payment will be due on the last day of the first month of each quarter, commencing on October 31, 2019, pursuant to the following schedule:

The deputy performing under this Agreement will be paid as a starting deputy at the salary set forth above.
