GENERAL DISCUSSION

5. AI-47787 USMCA Resolution, Commissioner, Precinct 3.

Commissioner Hale presented the USMCA (United States-Mexico-Canada) Resolution and spoke about the benefits to the State of Texas and Collin County. Commissioner Webb said he would need more time to gather information before he could vote on this item. The Court agreed to hold this item until January. (Time: 1:47 p.m.)

6. AI-47691 2020 Employee Reclassifications and Retitles, Human Resources.

Commissioner Fletcher asked to hold this item for a future court so Joe Wright, Constable 4, could be in attendance. Constable Wright is out for medical reasons. Judge Hill said this item impacts 21 different staff positions and asked if the Court could move forward with everything but the Constable discussion. Commissioner Fletcher agreed.

Cynthia Jacobson, Human Resources, presented HR's recommendations for the FY2020 Reclassifications. There was brief discussion regarding what Human Resources did recommend and did not recommend based on market data and standard practices.

HR did recommend the retitle of Deputy Sheriff to Sergeant for the Sheriff's Office. The Medical Examiner position was compared to an entry level position based on the job description. However, this position comes in at odd hours of the day and is sometimes the only person there. Taking this into consideration, HR recommended the pay grade above what market data shows. The Infrastructure Supervisor position requested a pay grade increase and a new title of Infrastructure Manager. HR recommended the pay grade be bumped but the title of the position remain the same.

A motion was made to adopt HR's recommendation on items 1 through 9 and 17 through 20. The motion failed for lack of a second. Another motion was made and seconded to approve all of HR's recommendations excluding 21 which was removed from the list entirely.

Commissioner Fletcher said the Deputy Constables are compensated as unlicensed peace officers, and she feels they should be compensated as licensed peace officers. The Commissioner said Constables are out in the field, serving warrants, and taking property away and should be compensated for being in harm's way.

Commissioner Hale requested the Court hold items 10 and 11 relating to Deputy Constables until next Court so Constable Wright could be in attendance. Commissioners Williams and Webb said this has been discussed before, and also it is a discussion for Budget – not reclassification.

Jim Skinner, Sherriff, explained the need for two deputy sheriffs to be retitled to sergeants and changed from pay grade 556 to 558. This group currently has 15 people reporting to one lieutenant, and they serve high-risk F1 and F2 warrants. The Reclassification submitted to HR would split this group of 15 into two groups of 7 with a supervisor in each group. The Sheriff asked if the requested title changes should be presented to Budget or HR.

Commissioner Hale would like to have an open discussion about the Constables but would like to wait until Constable Wright can be present. Judge Hill said he spoke to Constable Wright earlier in the day via phone and with Constables Williams, Knapp and Edwards to let them know this item was on the agenda today. The Judge feels the constables are well represented to have this discussion.

Constable Edwards, Precinct 2, agreed with Commissioner Fletcher. The Constable said his deputies are out in the field with Sherriff Skinner's deputies and back them up routinely, and he feels his deputies should draw the same pay.

Commissioner Webb said that he understood where the Constable was coming from and would like to discuss it more during Budget. The Commissioner said the problem with discussing this during Reclassification is it is not budgeted. Reclassifications are not in the budget that has been approved for the year. So any Reclassification approved through Court has a major financial impact on the payroll already approved through Budget.

Commissioner Williams said that approving the changes requested by the Constables would be breaking policy, and they can't pick and choose who they want to pay more or less. This is why the Court asks HR for market data regarding employee salaries. Commissioner Fletcher said that the reason the market data comes back lower for the deputy constables is they are only being compared to other deputy constables and not Police Departments which are Licensed Peace Officers. If our deputy constables were compared to our local municipal agencies, we would have the same data as the Sheriff's Office. The Commissioner cited Texas Code of Criminal Procedure Article 2.12 which states constables and deputy constables who hold a permanent peace officer's license issued under Chapter 1701 Occupations Code are Peace Officers.

Judge Hill asked Ms. Jacobson if our market data for deputy constables could be flawed. Ms. Jacobson said that the County compares constable to constable based off job duties and constables don't do 75% of what a police officer does.

Constable Sammy Knapp, Precinct 3, said back in 2012 the constable deputies and the deputies in the Sherriff's Office were paid the same. In the 2012 budget they budgeted down the constable deputies' salaries. Constable Knapp said that the job duties never changed from 2011 to 2012 to require getting a downgrade in pay.

Commissioner Fletcher and Commissioner Hale would like to schedule and make time to have this conversation during Budget this upcoming year. A motion was made to approve items 1-20 with item 21 having been withdrawn of HR's recommendations. (Time 2:30 p.m.)
