Commissioner Webb said the Regional Transportation Council (RTC) approved a loan to provide transit funding for a parking garage in the re-development of the Collin County Creek Mall. Commissioner Webb also stated that Virgin Hyperloop One made a decision on which location they were going with for the six-mile track. They selected a six-mile track between Arlington and the Dallas/Ft. Worth (DFW) Airport. Commissioner Webb said

the RTC vote was 35 for and 9 against the track being in Arlington because it's a city that has never supported transit. The motion was passed with an amendment stating if Arlington ever wanted a transit station, the city would have to be a part of a Transit Authority.

Commissioner Webb said the Texas Transportation Commission (TTC) met in Austin and decided to pull all the funds and put them all into one project for the next ten years which is the I-35 project in Austin. Commissioner Webb said the Court will wait for the TTC to put it in writing before submitting a resolution to the Court. (Time 2:06 p.m.)
