GENERAL DISCUSSION

5. AI-48303 COVID-19 Update, Administrative Services.

Bill Bilyeu, County Administrator, said the DSHS (Texas Department of State Health Services) website has regional information about COVID-19 including information on hospital beds. Locally, there is no widespread shortage for testing supplies, and Walgreens is gearing up to start drive-through testing. The drive-through testing center may put more pressure on our Health Department because the individuals who are likely to use it don't have a primary doctor. Therefore, the results would go to the Health Department for follow up. Mr. Bilyeu said the Health Department has a good core group of volunteers for additional support. As the work comes in, it goes to the team

leads, and they delegate to their team members. Staff input the information into a system that was built by IT (Information Technology) in a week. Over the holiday weekend, testing slowed down because some of the testing centers were closed.

HR (Human Resources) has been working hard on the stipend Commissioners Court approved last week. They are also tracking all hours worked by exempt employees as some are going above and beyond to support the public. HR is tracking all overtime and comp time accrued due to COVID-19. There was a good amount of interest in the PTO Sell Back that was approved by Commissioners Court. Approximately 100 staff members turned in the form.

Last week it was reported that Collin County was 25% positive on testing. This week there were 2,776 tests administered and only 17% were positive.

Judge Hill said he and the other Commissioners are taking a lot of questions on testing and the ability to test is growing every day. Judge Hill also wanted to remind the public that the Collin County Health Department does not do testing. The Health Department works to prevent the spread of COVID-19 and all diseases. Our active case count has gone down three days in a row, and Judge Hill is cautiously optimistic that this trend will continue.

Judge Hill formed a Collin County Economic Recovery Task Force comprised of businesses, industry experts, leaders from corporations and small businesses across the county and across various industries. He tasked this team with developing strategies to get Collin County families back to work safely and as soon as possible. The task force will also develop ideas for city, county, and state policy makers to promote a sustainable economic recovery in Collin County. Their guidance, taken together with the advice of our medical doctors and scientists, will provide the foundation of our strategy to get Collin County families back to work.
