GENERAL DISCUSSION

5. AI-48327 COVID-19 Update, Administrative Services.

Bill Bilyeu, County Administrator, said Judge Chris Hill rescinded his Executive Order #1 so all County offices will open Friday, May 1st. The County has taken extra precautions to ensure everyone's safety. Plexiglas will be installed in offices that don't have glass dividers. Public Works will continue to help with cleaning. The Purchasing Department received 110 pounds of hand sanitizer, so the offices will continue to have a supply, and the Fire Marshal is responsible for internally distributing the PPE to all offices. Departments are still rotating staff between working from home and in the office.

While the County was told it would no longer receive negative test results, the State decided to continue reporting these results. There are approximately 400 tests done daily, and 10% are positive. The lab work for the tests are \$100, and the antibody test is \$85 on top of the doctors' fees. FEMA (Federal Emergency Management Agency) still runs the drive-through testing center in Dallas and the National Guard is traveling county by county to test. It's best to check their websites to see where they will be. Collin County now has lab testing equipment, but test strips are in short supply.

Friday will be a big day for the County as the doors will be open to the public, and we will see a surge of public interaction. Stacey Kemp, County Clerk, said there will be an increase in people applying for their marriage licenses because no other County is offering that service. Ms. Kemp also believes there will be an increase in the number of people filing and getting copies of their current Assumed Name (DBA) because they will need it to apply for small business loans.
