7. AI-48414 Utilization of CARES funding, Commissioners Court.

Bill Bilyeu, County Administrator, led the discussion on the utilization of the CARES (Coronavirus Aid, Relief, and Economic Security) funding. The County needs to divide the funds into separate categories and allocate certain amounts to them, i.e., testing, housing, food and utility assistance. The Judge circulated a handout outlining his proposed budget for the CARES funds. Commissioner Fletcher said she feels strongly that they need to include a way to help businesses as well. Commissioner Williams wanted to make sure that the funds being used would help the citizens who have received evictions notices.

Janay Tieken, City of McKinney, Housing and Community Development Manager, confirms that the agencies would utilize the funds based on how the grant agreement allows them. The income portion of the grant is 200% AMI (Area Median Income) of the income at present time. Judge Hill and Commissioner Webb both stated that there needs to be an asset test along with the application to prevent being taken advantage of. Commissioner Williams asked Ms. Tieken if the funds would be used to pay off citizens back rent to help stop evictions. Judge Hill said the funds are retroactive from March 1st which would allow March, April and May's rent to be covered.

Judge Hill asked Ms. Tieken if the funds for the mortgage, rent and food assistance need to be in the same category, or if they should be divided into two. Ms. Tieken said that dividing them into two different groups would be easier to manage as the housing assistance would be paid directly to the lender/landlord, and the food assistance would go directly to the citizen.

The application for assistance will be through an online portal which will route them by zip code to a corresponding nonprofit. There are four cities that will be handling all of Collin County's applications, Allen, Frisco, McKinney and Plano. Ms. Tieken explained that they will accept help from any nonprofit that would like to help that meet the required standards. Judge Hill wanted to make sure they could get the funds to the citizens quickly and questioned if the County needs to front the money to the nonprofits or be reimbursed. Ms. Tieken said fronting the money up front would get the funds to the citizens the quickest.

The Housing and Community Development for the City of McKinney will see an overwhelming amount of nonprofits that would want to partner, and they are fully staffed and ready to take this on. They will have to create partnerships with the new nonprofits and vet each one to meet the CARES Act standard. If they don't meet the criteria set in place, the nonprofits are encouraged to help point citizens in the right direction.

There was a discussion on which cities should be included in getting funds from the CARES Act. Commissioner Williams wanted Sachse, Royce City and Garland to be included in the list of cities. The cities that were not listed are still receiving funds, they are just coming from the County's portion.

Mr. Bilyeu directed the conversation to COVID-19 testing. Judge Hill said that he has been in contact with the TDEM (Texas Division of Emergency Management) and the National Guard will be coming every two weeks to set up and run a drive through testing site. The County is proposing a voucher for uninsured citizens to be tested. All copays related to COVID-19 have already been waved at the Federal level. The voucher will allow citizens to get tested by a participating doctor. The doctor would accept the voucher just as if it were cash. The voucher would be turned into the County for reimbursement. There was a conversation about swab testing and antibody testing and if the antibody tests would be covered with the voucher. As of now, all FDA approved testing is covered.

Commissioner Webb said he wanted to make sure we reserved the right amount of money for testing. The proposed \$1.5 million seems too low and should be higher. Judge Hill said he is willing to pay what is needed for COVID-19 testing and if that budget needed to be increased then he would be happy to do so. Commissioner Fletcher also agreed that more money needs to be allocated to testing.

Mr. Bilyeu moved the conversation to PPE (Personal Protective Equipment). He said Purchasing is still buying PPE and they have spoken with Bruce Sherbet, Elections, to make sure the November elections will have enough PPE to run safe polling locations. Mr. Sherbet also discovered the touch screen polling machines can be used with Q-Tip. Michalyn Rains, Purchasing, said the County has masks on order and should be good, including elections. Wipes are the hardest to find right now, the County has some on order but expect to receive those in June. Mr. Bilyeu asked the Court if they would be buying PPE for internal use or to help businesses with a 72-hour gap protection. Commissioner Williams said if there is a way to fill the gaps then that's what we need to do, that's why we have the CARES Act. Commissioner Webb agreed. Any healthcare provider in the county will be able to put in an emergency request with the County for 72 hours' worth of supplies. Normal emergency requests for supplies goes to the city first then county and if the county can't fulfill the request then it gets sent to the state.

Commissioner Webb said he was supportive of the \$50M proposed. Commissioner Williams agreed but wants to make sure the smaller cities she had previously mentioned were included in the list of cities getting CARES Act money.

Mr. Bilyeu directed the conversation to LifePath and they need to be very specific in their requests. All requests need to be COVID-19 related. The CARES Act is not here to replace lost revenue because they weren't allowed to have their fundraiser.

Judge Hill circulated a revised CARES Act proposal. There was a conversation about giving all \$50M right now or holding back half to see how everything plays out. Ms. Tieken said a larger sum of money up front would be more

helpful. There is no indication from the Federal Government that any more money is coming available and if we use it all now there won't be any for the future.
