Dear Valued Customer,

As you are aware, many industries were affected by tariffs in 2019. ACS has absorbed these tariffs on certain products since implemented in May of 2019. Our hope was that these tariffs would be rescinded beginning of 2020, however, this is not the case. The latest ruling only suspends future tariffs at this point.

So, effective March 2, 2020, ACS will be passing through the 25% tariff rate on a select group of products that we import to round out our line. These products can be found on the attachment. They are all listed on Section 301, List 3 Affected Items from China.

In addition, we've received a 5% grill brick increase effective 1/1/20. We will also be adjusting for this on March 2, 2020 as well.
