On May 10th we notified you that the US Government increased the tariffs to 25% on some Chinese goods and raw materials effective that day and of our intent to implement price increases on items impacted by tariffs effective July 1, 2019.

Attached is your specific list of Impact and Malt items affected and your new costs. Affected Impact items directly imported from China will increase by 13%. Affected Malt PPE items directly imported from China will increase by 12%. Those items that contain components related to the affected HTS codes will increase by 6%.

Total Impact SKU's affected are 120 items primarily related to the Trigger Sprayer category and, additionally, some mopping equipment items with components made in China. Total Malt SKU's affected is 874. These items are disposable PPE clothing, the vast majority of which is supplied by China.

Accordingly, Impact will be implementing price increases on effected items, Monday, October 7, 2019. Additionally, the US Trade Representative announced that tariffs on some items (e.g. "List 4B") have been delayed until December 15, 2019.
