# 2. Public Comments

Denise Roustio, Farmersville, spoke on behalf of her home on CR 600 to address the issues with an R/V (recreational vehicle) park. The gentleman running it is not compliant with the county, state or federal government. There are septic tanks at the lowest point in the tributary to Lake Lavon. They have complained and gotten nowhere.

J. Spencer Phillips, Farmersville, said he has concerns with the construction of the R/V park. One concern is public safety because there will be 400 units, and the road is not designed for the increase in traffic. The second concern

is for safety because there will be 400 unknown people with no listed permanent residence adjacent to his property.

The main concern is the gentleman running the R/V park is operating a concrete crusher, and it is putting

crystalline silica into the air which is known to cause lung cancer. Complaints have been filed with the TCEQ (Texas

Commission on Environmental Quality), but nothing has been done.

Alicia Morris, Farmersville, said she resides across the road from the R/V park, and the concrete dust is unbearable

and covers everything. The biggest concern is traffic with 18-wheeler dump trucks frequently on the road causing

additional dust and loud noise. The Sheriff's Office has been contacted, and they have done a great job of

responding. They are hoping to find ideas to help with safety and security concerns.

Dale Davenport, Wylie, said he owns property next to the R/V park. Mr. Davenport said he has spoken with the

Sheriff's Office, and they do not have the manpower to watch over this. The septic permits have been sent out with

¾ inch water line, and the air quality and noise in that area are horrible. Mr. Davenport referenced Chapter 125 of

the Texas Public Nuisance Code.

Jim Skinner, Sheriff, said they have ordered an increase in commercial motor vehicle enforcement traffic for this

area. All of the concerns from the citizens are legitimate. Because of the way the road is configured, it will only be a

matter of time before one of those trucks is involved in a potentially fatal accident.

Billie Bullard, Farmersville, said she owns 41 acres adjacent to the R/V park. Ms. Bullard said she is concerned with

the quality of the air. The person building the R/V park changed the topography of the land, and now a portion of

her property has begun to flood. She is also concerned about the septic systems. (Time 1:47 p.m.)

GENERAL DISCUSSION

5. AI-48409 Public Hearing – Participation in the City of Plano Tax Increment Reinvestment Zone (TIRZ) Number

4, Budget.

Bill Bilyeu, County Administrator, said the public hearing was for the Collin Creek Mall TIRZ (Tax Increment Reinvestment Zone). Peter Braster, City of Plano Director of Special Projects, was present to answer any questions. Mr. Bilyeu explained there is a \$30 million cap on the County's contribution and the term will be 36 years. Commissioner Williams said this particular TIRZ is classic when looking at legislation and is really intended for

this type of redevelopment.

Commissioner Williams opened the public hearing at 1:55 p.m. and asked for comments. Hearing no comments, Commissioner Williams closed the public hearing at 1:55 p.m.

# 6. AI-48410 COVID-19 Update, Administrative Services.

Bill Bilyeu, County Administrator, provided the Court with the data on applications completed and processed for the Collin Cares Program. There is a lot of work to get these applications processed. Almost five times as many applications that have been approved have actually been declined, and they have been declined for specific reasons. The Small business loans have a drawback because they are not able to have an in-person visit to work through the application. The process is done online and dependent on phone calls which have held up the process.

There have been approximately 185 uninsured testing vouchers used. The National Guard reached out for testing this week. Because of the delay in testing results, every city in the County declined until they get their process together. This should be up and running in the next few weeks.

The pantry support has had a good response. Minnie's Food Pantry and other pantries have submitted their applications for pantry support. The program looks successful so far. The Fire Marshal has been distributing masks and gloves to the pantries from the Allen Community Outreach.

Some County staff have tested positive for COVID-19. The Sheriff's Office has been working with the Public Health Department, and the epidemiologist has watched tapes to help figure out who could have been in direct contact. The Public Health Department is an internal resource, and they have been very useful.

Candy Blair, Health Care, said the County has now been transitioned to Texas Trace for three weeks. They have been able to validate the data, and random samples have been done. The state's IT (Information Technology) Department has been remarkable. Any issues have been resolved, and the data is being updated on the County dashboard. Ms. Blair said testing has increased. In March there were 4,019 tests; in April there were 10,967 tests; and in May there were 22,000 tests. If the Health Care Department would have had to continue with data entry that would be the only task they would be able to do. But now, the epidemiologists are able to work with the long-term care facilities, schools, day cares, the Sheriff's Office and guide businesses. They have been able to mitigate fear and teach people how to isolate at home. Without the Texas Trace system, the Health Care Department would be caught up on entering numbers and not able to focus on the disease. Ms. Blair thanked the Court for their support. Locations for County employees to get immediate testing 24 hours a day seven days a week have been set up.

Mr. Bilyeu said the daily counts on the dashboard would have over peaked the County staffing. Texas Trace has many resources and contacting patients is happening quickly seven days a week. The positives are true positives and are not self-reported. These numbers have nothing to do with the states counting. The bottom right panel of the dashboard reports how many hospital beds are taken up in Collin County by COVID-19 positive patients. (Time 2:15 p.m.)

#### 7. AI-48414 Utilization of CARES funding, Commissioners Court.

Mr. Bilyeu said the Josephine Volunteer Fire Department is asking for COVID-19 money to use for a shower to wash off after any contact with COVID-19. The Court would need to validate the expense as a COVID-19 related expenditure, and the agency will incur the cost and come back to the Court for reimbursement. The City of Josephine has determined this project can be completed by the deadline which is December 30, 2020.

Commissioner Williams asked if there is a way to provide to 911 services the addresses of COVID-19 positive cases. Mr. Bilyeu said the State believes they would be giving false assurances to the departments now that COVID-19 is widespread. The State's direction is that they should treat every call as if there is COVID-19 there especially since there are people who are asymptomatic. Commissioner Williams made a motion to validate that the Josephine Fire Department's need for a shower is appropriate to be funded by the CARES (Coronavirus Aide, Relief and Economic Security) Act (Time 2:25 p.m.)
