1. In accordance with the Health Services Agreement, Section 9.3 "Annual Compensation Escalator" contract price effective October 1, 2020 is hereby increased by 3% using the U.S. Department of Labor Statistics, Consumer Price Index for Medical Care Services

Current contract pricing for adult detention facilities will increase 3% from \$5,704,995.36 to \$5,876,145.22 for a total increase of \$171,149.86.

Current contract pricing for juvenile detention facility will increase 3% from \$464,497.95 to \$478,432.89 for a total increase of \$13,934.94.

2. In accordance with the Health Services Agreement, Section 9.6 "Changes", contract is amended effective October 1, 2020 to the following:

Addition of 9.3 FTEs to the existing Adult Detention staffing plan to meet increased care requirements. The Psychiatry staffing will increase from 2.1 to 2.8 FTEs. The MHP staffing will increase from 4.6 to 7.6 FTEs. Add 4.2 FTEs for a Charge RN on each shift. Add 1.0 FTEs for a Pharmacy Technician The Dentist staffing will increase from 0.50 to .90 FTEs.

Payment for adult detention facilities to include the above CPI increase and additional FTEs will increase from \$5,704,995.36 to \$7,452,937.22 for a total increase of \$1,747,941.86. Eleven (11) monthly payments will be made in the amount of \$621,078.10, and one (1) monthly payment in the amount of \$621,078.12

Payment for juvenile detention facility to include the above CPI increase will increase from \$464,497.95 to \$478,432.89 for a total increase of \$13,934.94. Payment will be made monthly in the amount of \$39,869.41.

3. Extend contract from October 1, 2020 through September 30, 2021.

Except as provided herein, all terms and conditions of the contract remain in full force and effect and may only be modified in writing signed by both parties.
