2. Public Comments

Cindy Meyer, City of Parker Councilwomen, questioned the decision made by Commissioners Court on Friday, May 29, 2020 regarding the state controlling the tracking for COVID-19 cases. Ms. Meyer is concerned about the tracing that will be involved and if there will be a forced vaccine. Ms. Meyer also asked why Collin County was the only county that has signed up for this and suggested the item should have been tabled in order to give the Commissioners time to make the correct choice.

Stephanie Casson, Parker, agreed with Ms. Meyer, and she was very disappointed and believed choosing option three was an uninformed decision. Ms. Casson asked the Commissioners what they knew about the program and if the workers in the program would care about Collin County citizens. She questioned why Collin County was offered up as the guinea pig and said contact tracing is an infringement of our rights. Ms. Casson said she hoped there would be push back and the decision to go with Option Three wouldn't go through.

Commissioner Fletcher thanked the speakers for being very involved and for all the work they have done for the community. Commissioner Fletcher wanted to make it very clear that tracing and tracking are two separate things.

Public tracking was not part of what was voted for on Friday. Public tracing has been done for years. All health departments use public tracing to manage diseases like tuberculosis and HIV (Human Immunodeficiency Virus).

Commissioner Fletcher said a forced vaccine is also something she worries about, but that was not a part of what

was voted for on Friday. It was also mentioned that while we are the largest county to sign up for Option Three, we

are not the only county.

Commissioner Hale said he spoke with a Commissioner from Dallas County, and they are using the CARES

(Coronavirus Aid, Relief, and Economic Security) Act to fund the tracking this year. However, it will be handed off

to the state for next year. Commissioner Hale said we needed to take advantage of the state-funded mandate.

Commissioner Webb agreed with Commissioners Fletcher and Hale and said tracking has been done for a long

time, and it is not something the county hasn't already been doing. Commissioner Webb also said that this is the

first time the state has funded a mandate, and he would rather see those funds in the CARES Act be used for better

purposes like housing.

Judge Hill asked if there were any more comments. Hearing none, the Judge closed the public comments session at

1:45 p.m.

GENERAL DISCUSSION

5. AI-48410 COVID-19 Update, Administrative Services.

Bill Bilyeu, County Administrator, said the county received 40 vouchers from doctors requesting payment for uninsured testing, and that program is running smoothly. This week the National Guard will be here for testing in two locations. One is in Wylie, and the other is in Frisco.

The Zoom Grant went live this morning with the application to apply for housing and utility assistance. By 10:00 a.m. there were already 100 applications. The McKinney Housing Director said she will be able to get Commissioners Court a report based off of zip codes soon.

Commissioner Fletcher asked if someone staying in interim housing would qualify for assistance. Mr. Bilyeu said the CARES Act requires you to show that you were affected by COVID-19 by loss of a job or pay decrease.

Mr. Bilyeu said Judge Hill worked hard on getting the four interlocals with the cities managing the CARES Act funds signed and returned quickly. Direct payments have been sent to the cities from the Auditors Office.

Texas Trace is now handling all tracking of cases as of midnight on Sunday, May 31, 2020. There will be some overlap with cases Collin County is still tracking and cases the state is now tracking. There have been staff meetings with IT to make sure the dashboard on the county website can remain active and up to date. It will be frozen for a few days while the transition happens. However, the report Judge Hill sends out will continue to go out every day with accurate information. Our staff working current COVID-19 cases will do so until those cases have been cleared and the patient is out of quarantine.

Treasury has put out a FAQ (Frequently Asked Questions) list about how to use the CARES Act funding. Hazard pay is no longer a part of that list.

Mr. Bilyeu said the Compensatory Time and PTO Buy Back program the Commissioners offered was a success. In April, 178 employees choose to sell back 40 hours of PTO, and 507 employees sold back 40 hours of compensatory time. In May, 73 employees sold back 40 hours of PTO, and 441 employees sold back 40 hours of compensatory time.

Human Resources provided the additional dollar amounts for the hazard pay per pay period that the Court

approved. For law enforcement, it was an additional \$200,000 per pay period. For all other employees working in

the county buildings and not from home, it was \$110, 000 per pay period. Mr. Bilyeu said next Monday all employees not in a restricted class will return to work. If an employee is at high risk, they can bring a doctor's note

and continue to work from home.

Mr. Bilyeu spoke with Michalyn Rains, Purchasing, and confirmed the County can start accepting STAR (State of

Texas Assistance Requests). Items that can't be filled by the county will be sent to the state. This is for a 72-hour

gap until their supplier can get them the items they need. Mr. Bilyeu said there are checks so the system is not taken

advantage of. One request came in for 500 masks at a facility that only had 40 beds. The facility had sent this request

to multiple cities and counties, and the scam was caught. Mr. Bilyeu said the Fire Marshal has staff for handling

these requests.

There has been an increase in walk-in traffic with both the Tax Office and the County Clerk's Office. They are

following social distancing and only allowing a certain number of people into the office at one time.

Judge Hill said he would like to applaud Plano, Frisco, Allen and McKinney for working so quickly to get the interlocals signed and returned. The county has signed with the cities, and now the cities need to sign with the

nonprofits before the funds can be disbursed. Funding could be ready by June 4, 2020.

Executive Order Three restricted which employees in the county could apply for FMLA, and since they were

restricted from taking the time off they were offered a stipend. Executive Order Three was tied with Governor

Abbott's Disaster Declaration. There were two groups in Executive Order Three. Group 1 consisted of law

enforcement and health care workers who were to receive an extra \$6 per hour. Group 2 consisted of anyone

working inside the county buildings, and they were to receive an extra \$3 per hour.

Judge Hill said he is ready to terminate Executive Order Three and the extra \$3 per hour stipend since everyone is

coming back to work next Monday. The extra \$6 for law enforcement and health care works will be covered by the

CARES Act and will remain in place.

Commissioner Williams is concerned that, when they take the FMLA restrictions away, the Sheriff's Office will lose

a good deal of employees and asked if they were ready for that. Commissioner Fletcher agreed and said they need

to make sure the Sheriff is included in this conversation.

Commissioner Williams made a motion to terminate the Third Executive Order for Public Health Emergency.

Judge Hill said courts in Texas can't open until they have submitted a plan to the OCA (Office of Court Administration) and the OCA approves it. The plan must cover all spaces in the courthouse. The first plan submitted to the OCA only covered the judges' courtrooms and chambers and was rejected. Judge Hill believes the next plan they have prepared will be accepted by the OCA.

Commissioner Hale said we can't act like a private institution and make it mandatory to wear masks. Judge Hill agreed and added the courthouse will recommend following the CDC (Center of Disease Control) guidelines. Masks, temperature checks and health screening checks will be available, but they are not mandatory.

Commissioner Webb said he wants to work with the judges as much as possible but doesn't want the responsibly and power to advocate for the public sections of the courthouse.

If a new order is needed by the OCA that involves reopening the courthouse, it will come back to be approved through Commissioners Court. (Time: 2:34 p.m.)
