## GENERAL DISCUSSION

## 5. AI-48410 COVID-19 Update, Administrative Services.

Bill Bilyeu, County Administrator, said the County is back to full operations with a full staff. Staff are doing their best to maintain social distancing guidelines and limiting the number of people in the office. The new software the County purchased with the CARES (Coronavirus Aid, Relief, and Economic Security) Act was a large purchase. It will take some time to get set up and training completed. Mr. Bilyeu said he's hopeful to have it up and running in the next month.

The dashboard on the Collin County website shows 333 active cases of Coronavirus and only 13 of those are being tracked by Collin County. The rest are being tracked by the State. Mr. Bilyeu realizes the hospitalization section on the dashboard is incorrect and understated. The plan is to pull that section off the dashboard and point citizens to the State's website for that information. The State reports the hospitalization number based on which hospital and which county the patient is in. Commissioner Webb said he would like the County's dashboard to continue showing the information it has always displayed. Commissioner Fletcher said she wants to minimize the confusion and suggested that County staff pull the numbers from the State's website to update our dashboard so the public doesn't have to go to multiple websites to get the information. Commissioner Webb also mentioned they were assured by the State they would be able to pull any and all information from the website. A conversation followed on how to update the County dashboard with the correct information.

Mr. Bilyeu said the newest courthouse security plan has been submitted and approved by the OCA (Office of Court Administration). Purchasing and Budget are working with a temporary employment agency to get staff who would take citizens' temperatures and give advice on whether or not they should enter. The temporary staff would report to someone in the building in which they are working. That person would schedule their lunches and make sure they don't exceed a certain number of hours. If COVID-19 continues into 2021, we will have to look to Budget for funding this department because the cost is currently covered by the CARES Act. (Time 1:54 p.m.)

### 6. AI-48414 Utilization of CARES funding, Commissioners Court.

Bill Bilyeu passed out a map GIS/Rural Addressing (Geographic Information System) made that has dots representing all the applicants for the Collin Cares program. It will allow the Court to see if there was a heavy zone applying for relief. People from all over the county are putting in applications. There was a total of 1,462 applications from last week and this week. Fourteen of those applications were from Dallas County residents. So far there have been fifteen applications processed for a total of \$22,000. Farmersville, Royce City and Garland have

yet to claim their money from the County to cover their Coronavirus costs. There have been 135 people who took advantage of the uninsured testing voucher.

Mr. Bilyeu said he has received three requests from food pantries in the county for a total of \$1.7M and stressed the need to monitor this because at this rate it would exceed the budget the Court set. The cost for payroll should decrease because the stipends have now been suspended. PPE (Personal Protection Equipment) has been given to the food pantries, and ACO (Allen Community Outreach) will house all the supplies and handle distribution.

Commissioner Webb asked, since the county was back to full staff, is there a plan in place if someone in a department tests positive for COVID-19. Mr. Bilyeu assured Commissioner Webb they have a plan in place, and the departments are ready if that were to happen. (Time: 2:04 p.m.)

Commissioner Webb said this was the RTC's (Regional Transportation Council) first Zoom meeting. They approved the three-year TIP (Transportation Improvement Plan) draft for 2021-2024. It's physically constrained with 960 projects projected at a little over \$13 billon. The plan was approved and has been sent to the Texas Transportation Commission to be approved during their September meeting. The RTC also started the process of modifying the UTP (Unified Transportation Program) document that the federal government requires and the Regional 10-year plan. US 380, US 75 HOV (High-Occupancy Vehicle) lanes, the Collin County Outer Loop and the North-South Freeway east of US 75 were all included in the new TIP and UTP.

US 75 north of McKinney before Grayson County turns from three lanes down to two lanes for the last ten miles. The TTC (Texas Transportation Commission) has put money towards widening these last ten miles.

Lastly, the 2022 update to the Mobility 2045 Plan has begun. This plan is what the region will look like in the next 25 years. (Time: 2:09 p.m.)
