#### GENERAL DISCUSSION

5. AI-48736 Rayburn Electric 138-kv Transmission Line Project Preferences, Commissioner, Precinct 3.

The NTMWD (North Texas Municipal Water District) is in the early stages of development of a new water recovery facility just north of New Hope. The RECC (Rayburn Electric Country Cooperative) will be installing a new electrical transmission line to a substation adjacent to the NTMWD facility and is going through the process required by the PUC (Public Utilities Commission) to determine the route of the transmission line. Commissioner Hale has been following the process and asked the Engineering Department to evaluate the possible routes that RECC has identified.

Clarence Daugherty, Engineering, said both he and Commissioner Hale spoke with the cities of McKinney, New Hope and Princeton about the placement of the line. The three cities said they do not want the line placed through their city or any future development areas. Mr. Daugherty said it's best to not put the line in any area where the County plans on expanding a road with the planned thoroughfare. Judge Hill understands the cities saying they don't want the new line through their city. They are representing their constituents. All the routes go through Collin County, and Judge Hill said he would rather be silent on this item and let the cities and land owners send their letters protesting the routes rather than pick which constituents' land to go through.

Commissioner Williams said she shares the same concerns as Judge Hill and asked if the County has historically taken a position on powerline placement. Mr. Daugherty said he is not aware of this happening before.

Commissioner Hale made a motion to approve sending a letter to the Public Utilities Commission. The motion failed for lack of a second. (Time 1:53 p.m.)

## 6. AI-48410 COVID-19 Update, Administrative Services.

Bill Bilyeu, County Administrator, said in-person court hearings will resume August 1, 2020. There have been two trials approved by the OCA (Office of Court Administration) that start this month, but all others will resume August 1, 2020. The plan approved by the OCA had a section with temporary employees manning the doors, taking temperatures, handing out masks, and offering health screenings. If the Court plans to continue this next year, it will need to be put into the budget.

## 7. AI-48414 Utilization of CARES funding, Commissioners Court.

The food pantries have submitted their invoices to be reimbursed by the County, and as of July 6, 2020, they have requested \$1,991,943.17. Minnie's Food Panty will be submitting theirs soon for another \$500,000. This category will most likely exceed the budget provided by the courts, and Mr. Bilyeu said they could move more money into that category.

In regards to the housing grant, the County is currently at \$630,000 of the budgeted amount for an average of \$2,800 a payment. There was a conference call with the cities and the City Manager of McKinney to discuss the process and how to speed things up. After three weeks of training and operational movement, they expect this week to be moving a lot faster. Getting the correct documentation with the application have proven to be a struggle. There are 1,900 applications currently in the queue, and the majority of them are incomplete. The four housing directors say they feel comfortable with the process and should expect to increase the number of applications they can process.

The City of Dallas did not expand their housing program like Collin County did. They are at 80% of poverty and already put all the money out. The City of Dallas used Community Development Block Grants to fund their housing program. They did not use any CARES (Coronavirus Aid, Relief, and Economic Security) Act funds. Their citizens have been trying to get help from Dallas but are being sent to Collin County. Mr. Bilyeu spoke with the City of Dallas, and they will no longer be sending people to Collin County. All of the information has been shared with Commissioner Webb since this is his precinct. This information has also been shared with the staff that answers phone calls and the chatbot on the County's website.

Judge Hill asked if the \$630,000 for the housing also included utilities and food distributions. Mr. Bilyeu confirmed it did. Judge Hill said the Court budgeted \$45 million and has authorized a release of \$30 million to start. At this rate, if the numbers double they still won't reach the \$45 million budgeted. Mr. Bilyeu said the community directors feel they will be able to get all of it disbursed.

Judge Hill said, even if all the approved applicants came back three more times which they're allowed to do, we still wouldn't hit the budget set in place. Commissioner Hale asked how many approved applications there were

and how many were pending and waiting on documentation. Mr. Bilyeu said there were 360 approved applications and approximately 1,500 pending including those that aren't eligible. The goal is to get all the money out to people

who need it. He believes, as the summer moves on, the requests will grow in size. The County is seeing a good

distribution of the applications from all over showing that the word has gotten out.

The JPs (Justices of the Peace) were asked if there was an increase in evictions. They have all been in contact with

Judge Hill and have been told, if someone could benefit from the CARES Act, to direct them to the application.

Judge Hill said he spoke with the lead JP and asked if he thought there was a way the Justices could administer

housing funds. If someone was getting evicted and could prove it was COVID-19 related, they could award money

directly to the landlord on behalf of the renter.

Mr. Bilyeu said the latest directives from the Treasury allow the County and municipalities to be reimbursed at

100% for personnel costs for Law Enforcement and Healthcare. There is no need to directly tie their duties to

COVID-19 if the Court declares that some portion of their work involved COVID-19.

Judge Hill made a motion to recognize that the law enforcement and healthcare staff have been working to address

the threat of COVID-19 in our community and identify these personnel costs as related to and eligible for the

CARES Act grant through December 30, 2020. (Time: 2:08 p.m.)
