**RESOLUTION RELATING TO A PUBLIC HEARING AND APPROVING

LEGACY CHRISTIAN ACADEMY AND RELATED MATTERS**

COUNTY OF COLLIN §

WHEREAS, the Newark Cultural Education Facilities Finance Corporation (“*Corporation*”) created by the Town of Newark, Texas (the “*Town*”) has adopted a resolution authorizing the proposed loan (the “*Loan*”) in the maximum principal amount of \$8,000,000 under a loan agreement among the Corporation, Texas Capital Bank, N.A. (the “*Bank*”) and Legacy Christian Academy (the “*Borrower*”) as provided pursuant to Chapter 337, Texas Local Government Code (the “*Act*”) for the purpose of (A) refinancing the acquisition, construction, renovation and equipping of certain facilities of Legacy Christian Academy, a private Pre-K-12 school located at 5000 Academy Drive, Frisco, Texas 75034, including, but not limited to, construction of an approximately 57,500 square-foot, two-story facility containing classrooms, a performing arts center, a library/media center and common areas (the “*Project*”); and (B) paying certain expenses in connection with the issuance of the Loan;

WHEREAS, section 147(f) of the Internal Revenue Code of 1986, as amended (the “*Code*”) requires that the issuance of any qualified 501(c)(3) obligations be approved by either the governing body of the County or the chief elected executive officer of the County after a public hearing following reasonable public notice;

WHEREAS, attached hereto as Exhibit A is a Notice of Public Hearing (the “*Public Notice*”) which was published in a newspaper of general circulation in the County as required by section 147(f) of the Code which public hearing was conducted by the Corporation;

WHEREAS, the comments received from the public at the Public Hearing referenced in the Notice are summarized in the Certificate of Public Hearing attached as Exhibit B hereto;

WHEREAS, attached hereto as Exhibit C is the approval of the highest elected official of the County; and

**THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS COURT OF
COLLIN COUNTY, TEXAS THAT:**

Section 1. The County hereby specifically approves the Loan and the Project solely for the purpose of satisfying the requirements of section 147(f) of the Code and for no other purpose and is not to be construed as an undertaking by the County. The Loan shall not constitute a liability, an indebtedness or obligation of the County nor shall any of the assets of the County be pledged to the payment of the Loan.

Section 2. The County Judge is authorized to execute and deliver the Resolution.

Section 3. This Resolution shall become effective immediately upon its passage.

EXHIBIT A

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Newark Cultural Education Facilities Finance Corporation (the “*Corporation*”), a nonprofit corporation, will hold a joint public hearing on August 12, 2020, commencing at 10:00 a.m. at the Legacy Christian Academy North Campus Upper School Commons, 6525 Fighting Eagles Lane, Frisco, Texas 75034, to provide an opportunity for all interested persons to be heard with respect to a proposed loan (qualified 501(c)(3) bonds as defined in Section 145 of the Internal Revenue Code of 1986, as amended) from Texas Capital Bank, N.A. (the “*Bank*”) to the Corporation in the maximum principal amount of \$8,000,000 and a proposed loan from the Corporation to Legacy Christian Academy (the “*Borrower*”) in the same amount (collectively, the “*Loans*”); all pursuant to a Loan Agreement by and among the Corporation, the Bank and the Borrower.

The Loans are being made for the purpose of (A) refinancing the acquisition, construction, renovation and equipping of certain facilities of Legacy Christian Academy, a private Pre-K-12 school located at 5000 Academy Drive, Frisco, Texas 75034, including, but not limited to, construction of an approximately 57,500 square-foot, two-story facility containing classrooms, a performing arts center, a library/media center and common areas (the “*Project*”); and (B) paying certain expenses in connection with the issuance of the Loans. The Project is owned by the Borrower. The Loans are not payable out of taxes and are secured by and payable solely from funds provided by the Borrower.

All interested persons are invited to attend the hearing to express their views, both orally and in writing, with respect to the Loans and the Project. Any interested persons unable to attend the hearing may submit their views in writing to the President of the Board of Directors of the Corporation c/o Orrick, Herrington & Sutcliffe LLP, Attn: Tanya Fischer, 609 Main Street, 40th Floor, Houston, Texas 77002, prior to the date scheduled for the hearing.

WHEREAS, Legacy Christian Academy (the “*Borrower*”), in connection with a tax-exempt financing in the maximum aggregate principal amount of \$8,000,000, has requested the approval of the Financing (as described below) and the Project (as defined below) located in Collin County, Texas; and

WHEREAS, the “*Financing*” consists of a loan agreement among the Borrower, Newark Cultural Education Facilities Finance Corporation (the “*Corporation*”) and Texas Capital Bank, N.A. (the “*Lender*”) through which the Lender will make a loan to the Corporation, which in turn will make a loan to the Borrower (the “*Loans*”) for the purpose of (A) refinancing the acquisition, construction, renovation and equipping of certain facilities of Legacy Christian Academy, a private Pre-K-12 school located at 5000 Academy Drive, Frisco, Texas 75034, including, but not limited to, construction of an approximately 57,500 square-foot, two-story facility containing classrooms, a performing arts center, a library/media center and common areas (the “*Project*”); and (B) paying certain expenses in connection with the issuance of the Loans;


WHEREAS, in accordance with certain provisions of the Internal Revenue Code of 1986, as amended (the “*Code*”), as described below, notice of a public hearing was published in *Dallas Morning -News* in Collin County, Texas, on August 2, 2020, which notice provided that members of the public were invited to a hearing to be held on August 12, 2020 commencing at 10:00 a.m. at the Legacy Christian Academy North Campus Upper School Commons, 6525 Fighting Eagles Lane, Frisco, Texas 75034, in connection with the Financing and the Project; and

WHEREAS, it is necessary for the undersigned, as the highest elected official of Collin County, Texas (the “*County*”), to approve the Financing and the Project solely for the purpose of satisfying the requirements of section 147(f) of the Code;

NOW, THEREFORE, the undersigned highest elected official of the County, acting solely in his official capacity as County Judge, hereby approves the Financing; provided that such approval shall be solely for the purposes of section 147(f) of the Code, and neither the County nor the undersigned shall have any responsibility or liability for the Financing or the Project.
