GENERAL DISCUSSION

Judge Hill said this is a public hearing regarding the re- plat of lots 12A and 12B of the Cottage Hill Estates Subdivision. Clarence Daugherty, Engineering, said this is a simple action, and it does satisfy all rules including deed restrictions.

Judge Hill opened the Public Hearing at 1:36 p.m. Hearing no comments, the Judge closed the Public Hearing. With no further discussion, a motion was made to approve the item. (Time: 1:36 p.m.)

Bill Bilyeu, County Administrator, said the court system is still waiting on more direction from the State, but they have continued to function quite well. The dashboard data has been stable, but there have been inconsistencies with the data download the public uses and the data presented on the dashboard. It is updated daily by 10:00 a.m., and DSHS (Department of State Health Services) staff work on the data file download after 10:00 a.m. so the file may have more records than what is on the dashboard. The State has sent out an update of changes they are going to make to their dashboard. Mr. Bilyeu said changes to the wording of the notice currently on the dashboard could be considered.

Judge Hill said the dashboard reflects the original disclaimer which acknowledged that the numbers were significantly overstated. Now, the numbers are not overstated, but there is still a lack in confidence. However, the change does warrant an amendment to the way the statement is written. The Judge presented a proposed new disclaimer to the Court: "Notice: Collin County is providing this COVID-19 dashboard as a convenience to our residents. However, the data that comprise the dashboard are provided by the Texas Department of State Health Services (DSHS), and DSHS officials have acknowledged that the data for Collin County are inaccurate. We advise that Collin County lacks confidence in the data currently provided to us." Judge Hill said this disclaimer better reflects the current situation rather than saying "significantly overstated."

Commissioner Fletcher asked why there is still a lack in confidence and what the issues with the current data are. Judge Hill said, when Collin County staff was in charge of the data, they took great care to ensure the numbers would add up. There was a name for every single COVID-19 case. At times there were duplicates, but those were removed from the active case count. There was always an actual accounting for each number. The County does not have that now since the State has taken over. The State is not doing actual case counts, and their site has a formula for estimating data. The Judge said this is problematic and gave an example of how the numbers provided now fail basic logical tests.

Commissioner Fletcher said numbers are important, and the State has an enormous task. The public should know that these numbers are the best estimate. There is a way to rephrase the disclaimer in order to give the public some level of confidence. Commissioner Hale said he cannot assign any kind of

percentage of confidence to the data because the State has bounced their numbers around so much. Commissioner Fletcher suggested the wording "officials have acknowledged that the data for Collin County is not 100% accurate" instead of "inaccurate".

Judge Hill said, once the disclaimer was put in place, citizens were requesting accurate numbers or asking which data they could trust. The Judge said that is where the struggle is because you cannot tell a citizen which data to trust. Commissioner Williams said, before the disclaimer was added, the data was dramatically inaccurate and, until the Court did that, the State had made no effort to produce any accurate information. After the Court added the disclaimer, the State began to take some action, and the Court must keep the pressure on since it is still not correct. The fact that Collin County has pushed this issue is really important for the whole state. Commissioner Williams said she is not prepared to back off just because the State has improved somewhat. Commissioner Fletcher said there was a significant improvement once the thirteen people were added to the task force. Judge Hill said everyone wants the truth and accuracy. Commissioner Fletcher said she doesn't know if the data will ever be 100% correct. The Court had a brief discussion regarding data discrepancies.

The Judge said he is supportive of changing the words "inaccurate" to "not accurate". Regarding the last sentence of the proposal, he does not believe it needs to be changed. This issue is a big deal, and we deserve to get good numbers. Commissioner Webb said the language is strong and suggested the disclaimer could state, "The Texas Department of State Services and DSHS officials have acknowledged that the data are the State's current estimate. We advise residents that Collin County lacks confidence in the data currently being provided to us." Judge Hill said he preferred to leave his motion as presented. (Time: 2:05 p.m.)

7. AI-48414 Utilization of CARES funding, Commissioners Court.

Bill Bilyeu, County Administrator, said Erin Jones, City of Allen, will be giving the Court an update and proposed changes for the Collin County Cares Housing Program. Ms. Jones said they have two program proposals that could help expedite additional applications. The first proposal is to lower or remove the 25% loss requirement. As long as the applicant is able to show a COVID-19 related loss, they would qualify. There have been applicants that miss the cut off because they only have a 21% loss, and this has been recurring. The other recommendation is to change the period from four months to six months. This would allow the Collin Cares program to aide applicants for up to six months. Staff will be able to go back and contact applicants who are currently in the system and let them know they could qualify for more aide.

Judge Hill asked if there is a reason why the Court would be advised to change the month limit versus removing the month limit while leaving a \$10,000 limit. Ms. Jones said typically four months is considered limited or one-time assistance. Anything beyond that is considered long-term income assistance. Because of the COVID-19 pandemic, they have extended the short-term period to six months.

Commissioner Webb asked what the standard would be to determine if an application is COVID-19 based if the 25% loss requirement is removed. Ms. Jones said the applicants would still have to provide a COVID-19 related hardship, and it will be compared to pre and post March 1, 2020. If a loss is determined, the applicant would qualify. Currently, staff has to run the calculations to ensure there is a 25% loss. The removal of the 25% requirement would also streamline the application process.

Judge Hill asked how much additional need would be warranted if the Court were to make these two changes. Ms. Jones said there are currently 1,740 declined applications, and 288 of those failed to meet the 25% loss requirement. Based on this, there are 288 that could be contacted tomorrow to see if they are interested in reapplying. Commissioner Webb said he is supportive of changing the period to six months and reducing the required loss percentage. The Commissioner said he is nervous about completely eliminating the percentage requirement because he wouldn't want applicants to simply sign an affidavit and qualify. Commissioner Williams said the required loss is 15% for the small business program. Ms. Jones said they have tried to avoid the use of affidavits, and they are only used for major exceptions. The vast majority of applicants are able to provide clear documentation as to why they have a loss. Commissioner Fletcher made a motion to leave the \$10,000 cap in place, change the four-month period to six months, and reduce the required loss to 15%. (Time: 2:17 p.m.)

Mr. Bilyeu said the number of applicants for the Small Business program continues to rise at a consistent rate. There were three issues the Court would need to address. The first issue is the restriction that disallowed health care providers from applying. There are approximately fifty applications being held pending this discussion. Attorneys and hotels were also restricted from applying. Staff is recommending the Court include all three groups. Judge Hill said he was supportive of all three being eligible. Commissioner Williams said her concern would be for extended stay hotels because they act much like other real estate endeavors. Mr. Bilyeu said the hotel group is small enough that they would be able to disqualify any extended stay business that has received emergency housing assistance. Judge Hill made a motion, subject to the remaining provisions of the agreement, that health care providers, attorneys and hotels are eligible entities for the purposes of the Small Business Grant Program, with the qualification of hotels that have received residential aide on behalf of the residents. Commissioner Webb said he is

concerned with attorneys because they have sole proprietorships and partnerships, and would they apply individually or as a firm. Commissioner Hale said they would have to provide their tax documents proving they were operating as an individual entity. Commissioner Webb said attorneys could be included and determine if modifications are needed in the future. (Time: 2:25 p.m.)

Mr. Bilyeu said the contract that grant recipients will enter into is to guarantee they are going to continue to operate. The document has a DocuSign piece to it and, if the Court approves it, a policy would need to be put in place to allow the County Administrator to approve them after Commissioners Court. The concern is there could be 300-400 documents that have to be digitally opened and approved individually. Mr. Bilyeu said the Court will receive a list of the businesses and recommended grant amounts, and the Court will make the decision to approve it. Once approved, the DocuSign document will need to be executed. The Court members all agreed on this process. (Time: 2:27 p.m.)

Mr. Bilyeu said the spending update for CARES (Coronavirus Aid, Relief, and Economic Security) Act funds would be given at the next meeting. The food pantries are becoming oversubscribed, and the County is at \$4.5 million of the \$5 million allocated. Internal projects for COVID-19 are approximately \$500,000 underfunded so changes will need to be made to this budget. There is a group of non-profits coming next week to discuss a program for reimbursement of COVID-19 related costs. The Small Business Grant Program has a good subscription amount. Some applicants misunderstood the meaning of a non-profit business and were selecting it thinking it meant they had not made a profit. Staff members are working through these situations and verifying which businesses are truly non-profits. Judge Hill asked if they could have an audit or list of individuals and amounts from the Collin Cares Family Assistance Program. Mr. Bilyeu said they can provide very detailed information. The Judge said, if it is something that can be provided through the software, a physical report would not need to be generated. (Time: 2:34 p.m.)

8. AI-33858 Regional Transportation Council monthly update, Commissioner, Precinct 4.

Commissioner Webb updated the Court on the last RTC (Regional Transportation Council) meeting. The first item of interest was the upcoming legislative session and approval of a letter to all representatives

reminding them that transportation needs continue despite COVID-19. People are continuing to move to Texas in record numbers. Although COVID-19 has impacted congestion short-term, long-term needs will still be there. Additional funding was requested or at least to keep funding as it is presently. The funds are for transportation infrastructure, fair share allocation based on population, and to continue to allow the use of innovative tools to handle transportation needs at the local level.

The Council approved \$5 million dollars to continue to upgrade certain light signals within the metroplex so that freight movement can be optimized. There are certain areas that have a long line of trucks idling as they wait to get through these lights. The program was approved to start optimizing signals in key locations, and the lights will be timed based on how many trucks are lined up. This would allow the trucks to continue driving without having to stop. There will be reports provided with information on how this program is working. Commissioner Webb said they will get air quality points for this.

Another item of interest is the Silver Line rail project which is progressing. Part of the project is a trail system that will be adjacent to the rail line. The council approved the funding increase and use of development credits to get the projects completed at the same time.

As of July, bicycle and pedestrian traffic is up 22% over March. Free riding volumes are 10% under what they were pre COVID-19. Transit is down 45%-55%. Airport passenger traffic is also down more than 60%. Before COVID-19, the morning peak-time speed limit would go down. Currently, with the decrease in traffic, the speeds have not decreased. Motor fuel tax has decreased 2.2% since COVID-19. In July, the sales tax is up 4.3% over the previous year, and motor vehicle sales and rental taxes are down 3.7% since COVID-19. (Time: 2:43 p.m.)

Judge Hill recessed the meeting at 2:43 p.m. and called to order the Health Care Foundation and Toll Road Authority Meetings. Judge Hill reconvened Commissioners Court at 2:44 p.m.
