The Collin County Sheriff's Office respectfully requests the approval to accept funds through the Justice Assistance Grant (JAG) totaling \$14,011 in funding with no county match required. The performance period for the 2020 JAG Grant is October 1, 2019 to September 30, 2022.

This funding will be used to purchase equipment for Collin County Sheriff's Office Dive Team. This equipment will include 7 AquaFlex Public Safety Wetsuits, 2 Aqua Lung Rapid Diver Pro Systems, 7 Spectrum Full Face Masks, 7 XTX50 2<sup>nd</sup> Stage Regulators and 6 Earphone/Microphone Underwater Coms.

# Collin County Sheriff's Office JAG 2020 Grant Proposed Budget

Collin County Sheriff's Office Dive Team - The Collin County Sheriff's Office Dive Team is one of 2 metro area law enforcement teams certified for evidence recovery that responds to requests for assistance from within and outside its AOR making them a regional asset. The team is often called to locate, document, and recover everything from small items like cell phones, handguns, or knives to bodies, vehicles, or anything submerged in a body of water. The team works in all areas where an item may be submerged to include ponds, lakes, sewage treatment pools, or hazardous contaminated bodies of water. To accomplish this mission requires special equipment designed to provide a measure of safety to the diver entering a zero visibility environment often littered with underwater hazards.

The Collin County Sheriff's Office is seeking replacement of some of this equipment to include exposure protection through the purchase of wetsuits and full face masks. In addition, the purchase of communication equipment necessary to notify other divers or safety personnel of a problem. Finally, the purchase of rapid deployment emergency systems that allow for 2 back-up divers to quickly enter the water when a rescue becomes necessary. The purchase of these items will replace aging equipment while enhancing the efficiency and safety of dive operations.
