PROJECT DETAIL:

- KSS will add one camera to the existing system at the security desk.

PROJECT RESPONSIBILITIES:

- KSS will provide and install one P3227-LV Dome Camera Ceiling Mounted above the Security Desk
- KSS will provide and install one Network IP cable drop to the new camera
- KSS will provide and install one Milestone Corporate Device License and CarePlus License
- KSS will provide and install one 128gb SD Card in the New Camera.
- KSS will Setup and Configure the new camera into the existing Milestone System.

EXCEPTIONS AND CLARIFICATIONS:

- KSS will install components and materials to be compliant with the Uniform Building Code (UBC), national Electric Code (NEC), Municipal Fire, Life Safety, and Americans Disabilities Act (ADA), Permits, Codes and Regulations.
- KSS provides this design "as-is;" should any project document or site abnormalities exist, KSS will advise the Customer regarding details and recommended or necessary design cost adjustments.
- KSS provides Comprehensive Extended Annual Maintenance Programs separately.
- KSS Project Schedule Planning and duration assumes installation commencement, dependent upon manufacture product delivery, site preparation, Customer's Authorization-to-Proceed, Customer availability, and current schedule conditions.
- KSS will perform all work related to this proposal during KSS's normal business hours unless otherwise specified, and an additional charge to the Contract shall be made for any mutually agreed upon overtime.
- The Customer will identify a Project Supervisor for project coordination and a System Administrator for ongoing system management.
- The Customer will provide written consent of Change Orders in advance of work commencement for Changes/Additions to the Scope of Work and/or Project Detail.
- The Customer will be responsible for appropriate data paths necessary to support system communications; including network static and/or dynamic IP addresses and/or standard telephone service, prior to commencement of work.
- No provisions of this Proposal/Contract shall server to void our entitlement to timely payment for properly performed work or suitable stored material, nor void any of KSS's rights under Mechanics' Lien Laws.
- The Customer and KSS agree no other work stated outside the attached Scope of Work, whether expressed or implied, will be valid unless in writing and approved by both parties.
- Total Cost of Camera includes the 3 year Manufacturer Hardware Warranty.
