**An order of the Canvass Election Special Session Commissioners Court approving the filing of the November 11, 2020 minutes.**

On Wednesday, November 11, 2020 the Commissioners Court of Collin County, Texas, met in Special Session in the Commissioners Courtroom, Jack Hatchell Collin County Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating, to wit:

1. Judge Hill called to order the meeting of the Canvass Election Special Session Collin County Commissioners Court at 1:37 p.m. and adjourned the meeting at 1:41 p.m.

#### GENERAL DISCUSSION

2. **AI-49433** Canvass the results of the November 3, 2020 General and Special Election, Elections.

Bruce Sherbet, Elections Administrator, said Collin County had a historic record of voter turnout at 76.02%. Mr. Sherbet said he looked back at six presidential elections, and none were close to this election's turnout. There were approximately 500,000 voters and 2,100 limited ballots. Collin County had 6,000 provisional ballots of which 2,000 counted. There are four runoff elections for the cities of Celina, Anna, Frisco and Princeton. Early voting was approximately 92% of the overall voting turnout. Mr. Sherbet presented to the Court the vote totals report and said they have counted 100% of the votes.

Judge Hill said the runoff elections are for city council positions needing majority votes. The Judge asked if Class A cities that have multiple candidates go through with plurality. Mr. Sherbet said yes, except for Princeton, because they extended their term to three years.

Judge Hill asked if it would be prudent to create a ballot style specifically for the out of county races. Mr. Sherbet agreed and said he has already spoken with the vendor about creating them.


