GENERAL DISCUSSION

5. AI-48410 COVID-19 Update, Administrative Services.

Bill Bilyeu, County Administrator, said the court system continues to operate as before. The Health Care Department had a conference call with the State to work on vaccination distribution programs. The first order of vaccines would be for first responders and health care providers. There are multiple vaccines, and the first vaccine requires a second dose of the same brand 30 days later. Hopefully, the State's vaccination system will send reminders and notices to citizens. One issue is that the vaccines must be stored at an extremely low temperature, and the required freezers are not available in the normal market place. A large pharmaceutical chain store has bought all of the small freezers that were available to prepare for distribution. Part of the plan was to store most of the vaccines at teaching hospitals or large hospitals because they have large freezer space. However, that would not be possible because of other items in those freezers that cannot be stored with the vaccine. Vaccine distribution will be operated mostly through private providers.

If the vaccine distribution occurs, it will be on or after January 1, 2021. By then, the CARES (Coronavirus Aid, Relief, and Economic Security) Act funding will have lapsed. The Court will need to discuss whether funds will be held with the expectation that congress allows the money to rollover.

There have been at least ten people in the hospital each week for the last month. The costs for those visits are paid by the County. The County can expect to have demands and needs beyond January 1, 2021, and how to fund those demands is a question for the Court.

Commissioner Fletcher asked for assurance that the vaccines are not going to be mandatory. Mr. Bilyeu said there is no expectation that the vaccine will be mandatory. The vaccines that are mandatory in Texas do have waivers to opt out. It would take legislative action to mandate the COVID-19 vaccines. Commissioner Webb asked if anyone from the state or local level is pushing the federal government to extend the deadline for the use of CARE Act funds. Mr. Bilyeu said the National Association of Counties and health organizations are pushing for an extension. (Time: 1:49 p.m.)

NO ACTION

6. AI-48414 Utilization of CARES funding, Commissioners Court.

Bill Bilyeu, County Administrator, said the Emergency Housing Program closed down to new applications on Sunday. The housing directors and non-profits said November 1, 2020, was their deadline in order to close out their books. Any applicants who have submitted their application and were already part of a program or under consideration will be eligible. The program will continue to pay rents through December 2020. Unused funds will be returned to the County.

To cover November costs, food pantries will need to have all claims in by December 9, 2020. The budget for food pantries will be oversubscribed. An application was just received for \$600,050. Mr. Bilyeu said the \$7 million will not be enough and recommended the Court increase the budget to \$9.5 million. Part of the issue is there will be larger claims due to Thanksgiving.

Commissioner Webb asked for an estimated cost for the vaccine distribution. Mr. Bilyeu said, if the County doesn't cover the internal safety costs, the cost would be approximately \$10 to \$15 million. Commissioner Webb said the Court will probably need to hold that amount in reserves.

Mr. Bilyeu said the items on page 435 of the Court packet were budgeted items, and additional items have been added. In order to complete county projects and cover IT costs, an additional \$4.5 million is needed. There is ample money in the testing budget, and it is anticipated the County will have funds returned from the Housing Program. Mr. Bilyeu requested the Court allocate money from the reserve funds into county projects and food assistance.

Commissioner Fletcher made a motion to allocate \$4.5 million from reserves of the CARES Act funds to county projects and \$1.5 million to food pantries. (Time: 1:56 p.m.)

Mr. Bilyeu said the Elections Office has been working hard to make the polling locations safe. They have extra employees in every location, and the County is encouraging citizens to vote. Commissioner Hale asked for the current status of the various lawsuits for poll workers, voters and poll watchers as far as mask mandates. Mr. Bilyeu

said there was an article stating masks were mandated due to an overnight ruling. The federal court stayed that order, and the Secretary of State issued an order with instructions regarding masks. At this point election officials

and voters are not required to wear masks. Elections personnel have asked for everyone to show courtesy to those

either wearing or not wearing a mask. (Time: 2:00 p.m.)

Commissioner Webb recessed Commissioners Court at 2:00 p.m. and called to order the Health Care Foundation

and the Toll Road Authority meetings. Commissioner Webb reconvened Commissioners Court at 2:01 p.m.
