As a requirement to keep her job and work from home, her employer required she have and maintain a dedicated HIPAA compliant line in order to perform her duties. To allow her to work from home and maintain her job, Agape installed and maintained a dedicated, HIPAA compliant internet line at the Agape property in which our client lived with her children. Agape helped H.W. relocate to housing she could afford in 8/2020.
