Dear Judge Hill and Collin County Commissioners:

As a result of the COVID-19 pandemic response, school districts in your county, Collin County, have been working tirelessly to provide an outstanding education to our collective students while maintaining a safe learning environment for our students and a safe workplace for our staff.

The authors of this letter represent 185,273 students and 24,304 employees in Collin County. These K-12 school systems, the school districts you represent, have rapidly redesigned the education system to include quality remote instruction and put health and safety protocols in place at great expense to the local districts. Our districts have requested reimbursement for all eligible COVID-related expenses allowed by TDEM or FEMA; however, as you see below, the reimbursements granted leave millions of dollars spent by local districts with no relief in sight.

The reopening of schools is a key factor in reviving the Collin County economy and maintaining the financial recovery of each community. Support for providing relief to school districts for these unanticipated expenditures represents a commitment from our County to the economic recovery of all of Collin County.
