
On September 13, 2010 the Health Care Foundation Board of Trustees of Collin County, Texas, met in regular session with the following members present and participating to wit:






During such session the court considered a request for approval of Amendment No. 1 to the Lease Agreement with the Collin County Health Care Foundation.


