

PROJECT NAME: Plano Tax Office Cameras

PROJECT SCOPE

Knight Security Systems will provide and install the cameras and server. The required switch with the correct power output for the POE cameras will be provided and installed by Collin County.

PROJECT DETAIL:

- The server will be mounted in the customer provided rack and plugged into a customer provided UPS. The configuration of the server is included.
- The camera views will be decided by the customer prior to the start of the project. IP addresses will be supplied for all the cameras and server prior to the start of the project.
- The cables will be run from the server switch to the camera locations. Each end of the cable will be terminated
- and a patch cable will be used to connect to the switch and camera.
- The following locations will have a camera as shown on the attached drawing.
 ***Axis products carry a 3 year manufactures warranty.

Collin County has elected to provide the switch ports required to operate the cameras to camera specification.

- KSS will provide and install one Milestone Corporate Device License and CarePlus License for each device.
- KSS will Setup and Configure the new cameras into the existing Milestone System.

EXCEPTIONS AND CLARIFICATIONS:

- KSS will install components and materials to be compliant with the Uniform Building Code (UBC), national Electric Code (NEC), Municipal Fire, Life Safety, and Americans Disabilities Act (ADA), Permits, Codes and Regulations.
- KSS provides this design "as-is;" should any project document or site abnormalities exist, KSS
 will advise the Customer regarding details and recommended or necessary design cost
 adjustments.
- KSS provides Comprehensive Extended Annual Maintenance Programs separately.
