6. AI-48410 COVID-19 Update, Administrative Services.

Bill Bilyeu, County Administrator, said the janitorial and temporary services contracts expired last week, so it is now down to staffing.

There are quite a few cases in the County that are in the quarantine period. Information was sent to departments and elected officials letting them know about the expiration of the special pay for quarantine time. The County received feedback from Toyota, the City of Sachse, and a few other small cities stating they would be extending the quarantine pay beyond the expiration of the Act. Cynthia Jacobson, Human Resources, said she has seen some dialogue indicating Congress will extend this program in their latest package.

Monika Arris, Budget, said, from the GFOA (Government Finance Officers Association) side, the CARES Act funding will more than likely be a reimbursement for the continuation of testing and for vaccines.

Judge Emily Miskel, 470th District Court, forwarded a notice from the OCA (Office of Court Administration) stating the plan that was put in place will need to be revisited. The State has stopped all in-person judicial transactions until the plan has been revamped. Until then, all hearings must be conducted via Zoom. The notice also stated the eviction process in JP (Justice of the Peace) courts can begin as of December 31, 2020.

With this payment and the other payments, the Court has extinguished all CARES Act funding. There may be some expenses,

Judge Hill thanked Mr. Bilyeu and the staff for all of their hard work. It is a difficult task when the federal government gives you \$171 million dollars to spend. The Court made a decision early on that these were tax dollars paid by the citizens, and they would put those dollars to use to help families that were struggling. Everything has been done with openness, transparency, and integrity to make sure the dollars were spent well and to make sure they were to help the citizens of Collin County. The Judge also thanked the cities, agencies, and everyone else who has assisted in serving the people they represent. (Time: 1:45 p.m.)
