Dear Judge Hill,

The rules for this program (43TAC § 29.3) were established based on Transportation Code §201.706, Local Government Assistance in 1997. The rule requires the Department to give materials to the counties to assist in repairing and maintaining county roads damaged by the impact of the 2060 Weight Tolerance Permits. This legislation requires that at least \$6,000,000 worth of materials be given each year to counties in the state. The allocation to all of the state's 254 counties should be primarily satisfied with surplus materials.

The Department of Transportation, pursuant to the General Appropriations Act may use funds appropriated by this Act to assist cities with the maintenance of city streets by providing engineering/maintenance expertise on roadway maintenance and when surplus materials are available, the department shall make available the surplus materials to any local government needing such materials.

The fiscal year 2021 allocation for Collin County is \$31,143.00.

The following is a listing of surplus material, the material stockpile location, the estimated date of availability, quantity and unit price:

If Collin County is interested in acquiring any of the above listed surplus materials please reply in writing within forty five days of the date of this letter. Your response should include specific quantities, types and dollar values of surplus materials being requested based on the information provided above. Upon receipt of your written request we will make arrangements for Collin County to take possession of the material. If we have not received your response within forty five days, the amount set aside for your county will be made available to other counties within the Dallas District.
