WHEREAS, the Red River Education Finance Corporation (the "Issuer") has previously entered into a Loan Agreement dated as of December 20, 2016 (the "Original Loan Agreement") and is empowered pursuant to Chapters 53 and 53A of the Texas Education Code, as amended (the "Act"), to sell and deliver bonds and notes for the purpose of financing and refinancing the cost of education facilities, as defined in the Act; and

WHEREAS, the Issuer has issued its Issuer Note (the "Original Issuer Note") and the Co-Borrowers have issued their Co-Borrower Note pursuant to the Original Loan Agreement; and

WHEREAS, the Issuer has previously issued the Original Issuer Note for John Paul II High School, Inc., a Texas nonprofit corporation and Section 501(c)(3) organization ("John Paul II") in a maximum aggregate principal amount not to exceed \$30,000,000 for the purpose of financing and refinancing John Paul II High School located at 900 Coit Road, Plano, Texas (the "Project"); and

WHEREAS, the Co-Borrowers have requested that the Original Loan Agreement, the Original Issuer Note and the Co-Borrower Note be amended to reduce the interest rate and extend the maturity of the Issuer Note and the Co-Borrower Note; and

WHEREAS, the Issuer will execute and deliver an Amendment No. 1 to Loan Agreement (the "Amendment") among the Issuer, the Co-Borrowers and the Lender and an amended Issuer Note (the "Amended Issuer Note") for that purpose;

WHEREAS, pursuant to Section 147(f) of the Internal Revenue Code of 1986 (the "Code"), the Issuer has caused to be published a notice of a public hearing (the "TEFRA Notice") with respect to the reissuance of the Amended Issuer Note and the financing and refinancing of the Project, and held such a hearing after reasonable notice on December 21, 2020 (the "TEFRA Hearing"); and

WHEREAS, pursuant to the provisions of Section 147(f) of the Code, the Commissioners Court of Collin County, Texas, after the TEFRA Hearing, must approve reissuance of the Amended Issuer Note by the Issuer to enable the Amended Issuer Note to qualify as tax-exempt obligations under the Code; Now Therefore,

BE IT RESOLVED BY THE COMMISSIONERS COURT OF COLLIN COUNTY, TEXAS:

- Section 1. The Commissioners Court, solely for the purposes of Section 147(f) of the Code, hereby approves the reissuance of the Amended Issuer Note by the Issuer to refinance the Project for the benefit of John Paul II.
- Section 2. The foregoing approval is given in accordance with the provisions of Section 147(f) of the Code and for no other purposes and is not to be construed as an undertaking by Collin County, Texas. The Amended Issuer Note shall not constitute a liability, indebtedness, or an obligation of Collin County, Texas nor shall any of the assets of Collin County, Texas be pledged to the payment of the Amended Issuer Note.
- Section 3. This resolution shall take effect immediately from and after its passage and it is accordingly so resolved.
