

WEEKLY EVERBRIDGE MESSAGE

This is the Collin County COVID-19 Vaccination update. This message does verify that you are registered on the Collin County vaccination waitlist. For the week of February 1st, Collin County Healthcare Services has been allocated a total of 9,750 doses of vaccine from the State of Texas. We expect to receive this vaccine shipment the early part of the week and will then begin scheduling appointments in order from the Collin County waitlist.

Based upon the vaccine that has already been delivered, Collin County and our partners are currently scheduling those on the waitlist up to number 8007.

The Collin County waitlist will continue to be used to schedule appointments in the order that people registered. Please insure that you are on the waitlist at collincountytx.gov

Please continue to seek alternative locations to receive your vaccination. Local pharmacies, doctors, hospitals and clinics are also receiving doses and operate their own waitlists. Information on the location of other vaccine providers can be found at collincountytx.gov

Here is what you need to bring:

- A valid photo identification card. Without a photo ID, you may be unable to receive your vaccination.
- Your health insurance information or ID card. If you do not have health insurance, THAT IS OKAY. The vaccination will still be \$0 cost to you.
- If this is a second dose, the COVID-19 Vaccination Record Card.
- If possible, a printout of this email.

Here is what you should know:

- Only [INSERT NAME] may receive the vaccine for the time slot above.
