

An order of the Collin County Commissioners Court adopting the Collin Cares recovery plan.


The Collin County Commissioners Court hereby adopts the Collin Cares recovery plan and approves the utilization of federal Coronavirus Aid, Relief and Economic Security (CARES) Act funding, as follows:

- \$3 million for COVID-19 testing for uninsured individuals
- \$5 million for personal protective equipment (PPE)
- \$45 million for housing (rent and mortgage), utilities, and food assistance. The Court has authorized an initial disbursement of \$30 million from the total of \$45 million.
- \$5 million to help re-stock local food pantries
- \$50 million to cities for COVID-19 costs and recovery efforts
- \$40 million for county COVID-19 costs



The Collin County Commissioners Court hereby approves the utilization of CARES Act funds for a small business grant program in the amount of \$15,000,000.


